

The Senate Committees on Public Services and on Finance to which were referred H. B. No. 1246, introduced by Representatives Ramos, Sarmiento and Ungab, *entitled*:

**"AN ACT  
ESTABLISHING A SATELLITE OFFICE OF THE LAND  
TRANSPORTATION OFFICE (LTO) IN THE MUNICIPALITY OF IROSIN,  
SORSOGON AND APPROPRIATING FUNDS THEREFOR."**


have considered the same and have the honor to report it back to the Senate with the recommendation that the attached H. B. No. 1246 be approved with amendments, *to wit*:

1. On page 1 line 2, delete the word "satellite" and replace it with the words "REGULAR DISTRICT";
2. On the same page 1, line 4, after the word "transportation" and before the word "office" delete the word "satellite" and replace it with the words "REGULAR DISTRICT";
3. On the same page 1, line 11, after the conjunctive "in", delete the word (two) and the corresponding number and replace it with the conjunctive "A";
4. On the same line and page, delete the letter "s" from the word "newspapers", and
5. Lastly, on the title, after the conjunctive "a" and before the word "office", delete the word "satellite" and replace it with the words "REGULAR DISTRICT".





AN ACT ESTABLISHING A SATELLITE OFFICE OF THE LAND  
TRANSPORTATION OFFICE (LTO) IN THE MUNICIPALITY OF  
IROSIN, SORSOGON AND APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled;*

1           SECTION 1. There shall be established, under the direct supervision of  
2 the Department of Transportation and Communications, a satellite office of the  
3 Land Transportation Office (LTO) in the Municipality of Irosin, Province of  
4 Sorsogon to be known as the Irosin Land Transportation Satellite Office.

5           SEC. 2. The Secretary of Transportation and Communications shall  
6 immediately include in the Department's programs the operationalization of  
7 the LTO Satellite Office in the Municipality of Irosin, Province of Sorsogon,  
8 the funding of which shall be included in the annual General Appropriations  
9 Act.

10           SEC. 3. This Act shall take effect fifteen (15) days after its publication  
11 in the *Official Gazette* or in two (2) newspapers of general circulation.
