The Committee on Education, Arts and Culture and the Committee on Finance to which was referred House Bill No. 5406, introduced by Representatives Agyao, Cojuangco (K.) and Ungab, entitled:

**"AN ACT  
SEPARATING THE KALINGA NATIONAL HIGH SCHOOL - AMBATO TINGLAYAN  
ANNEX IN BARANGAY AMBATO-LEGLEG, MUNICIPALITY OF

AN ACT SEPARATING THE KALINGA NATIONAL HIGH SCHOOL –  
AMBATO TINGLAYAN ANNEX IN BARANGAY  
AMBATO-LEGLEG, MUNICIPALITY OF TINGLAYAN,  
PROVINCE OF KALINGA FROM THE KALINGA NATIONAL  
HIGH SCHOOL, CONVERTING IT INTO AN INDEPENDENT  
NATIONAL HIGH SCHOOL TO BE KNOWN AS TINGLAYAN  
NATIONAL HIGH SCHOOL OF ARTS AND TRADES  
AND APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

- 1           SECTION 1. The Kalinga National High School – Ambato Tinglayan  
2 Annex in Barangay Ambato-Legleg, Municipality of Tinglayan, Province of  
3 Kalinga is hereby separated from the Kalinga National High School and  
4 converted into an independent national high school to be known as Tinglayan  
5 National High School of Arts and Trades.
- 6           SEC. 2. All personnel, assets, liabilities and records of the Kalinga  
7 National High School – Ambato Tinglayan Annex are hereby transferred to  
8 and absorbed by the Tinglayan National High School of Arts and Trades.
- 9           SEC. 3. The Secretary of Education shall immediately include in the  
10 Department's program the operationalization of the Tinglayan National High

1 School of Arts and Trades, the initial funding of which shall be charged against  
2 the current year's appropriation of the Kalinga National High School – Ambato  
3 Tinglayan Annex. Thereafter, the amount necessary for the continued  
4 operation of the school shall be included in the annual General Appropriations  
5 Act.

6 SEC. 4. The Secretary of Education shall issue rules and regulations  
7 necessary to carry out the purpose of this Act.

8 SEC. 5. This Act shall take effect fifteen (15) days after its publication  
9 in the *Official Gazette* or in a newspaper of general circulation.
