MR. PRESIDENT:

The Committee on Environment and Natural Resources to which was referred House Bill No. 4643, introduced by Representatives Roman and Matugas, entitled:

"AN ACT

RECLASSIFYING A PARCEL OF LAND OF THE PUBLIC DOMAIN LOCATED IN THE MUNICIPALITIES OF DINALUPIHAN AND HERMOSA. PROVINCE OF BATAAN AS AGRICULTURAL LAND OPEN TO DISPOSITION FOR COMMERCIAL, RESIDENTIAL AND PURPOSES"

has considered the same and has the honor to report this bill back to the Senate with the recommendation that House Bill No. 4643 be approved with the following amendments:

- 1. On page 4, line 18, before Section 2, insert two (2) new sections which shall read as follows:
 - "SEC. 2. DISPOSITION OF THE AGRICULTURAL LANDS. THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR) SHALL ALIENATE THE AGRICULTURAL LANDS IDENTIFIED IN THE PRECEDING SECTION THROUGH THE ISSUANCE OF A FREE PATENT, REGARDLESS OF THE IDENTIFIED USES OR PURPOSES OF THE LOTS BEING APPLIED FOR, TO ANY CITIZEN OF THE PHILIPPINES WHO HAS CONTINUOUSLY OCCUPIED CULTIVATED EITHER OR THROUGH PREDECESSORS-IN-INTEREST OR WHO SHALL HAVE PAID THE REAL ESTATE TAX THEREON WHILE THE SAME HAS NOT BEEN OCCUPIED BY ANY OTHER PERSON FOR AT LEAST TEN (10) YEARS PRIOR TO THE APPROVAL OF THIS ACT. NOT TO EXCEED ONE (1) HECTARE PER APPLICANT: PROVIDED,

THAT THE DENR SHALL RESERVE AND AWARD LANDS OR LOTS TO THE MUNICIPAL GOVERNMENTS OF DINALUPIHAN AND HERMOSA, THEIR BARANGAYS AND OTHER AGENCIES OF THE NATIONAL GOVERNMENT FOR ESSENTIAL PUBLIC AND QUASI-JUDICIAL PURPOSES AND/OR SERVICES SUCH AS SCHOOL BUILDINGS, ROADS, PUBLIC PLAZAS, WATERWORKS SYSTEM, HEALTH CENTERS AND SIMILAR OFFICES AND PURPOSES: *PROVIDED, FINALLY,* THAT ANY TITLE ISSUED OVER LANDS FOR PURPOSES OF THE AGENCIES OF THE NATIONAL GOVERNMENT FOR QUASI-PUBLIC PURPOSES SHALL BE IN THE NAME OF THE REPUBLIC OF THE PHILIPPINES.

THE PROVISIONS OF COMMONWEALTH ACT NO. 141, OTHERWISE KNOWN AS THE "PUBLIC LAND ACT", AS AMENDED, NOT CONSISTENT HEREWITH, SHALL BE APPLICABLE: PROVIDED, THAT ACTUAL OCCUPANTS OF RESIDENTIAL LOTS WITHIN THE BUILT-UP AREAS SHALL BE GIVEN PRIORITY IN THE APPLICATION FOR TITLES AND THE ISSUANCE OF FREE PATENTS PURSUANT TO THIS ACT.

- SEC. 3. PRESERVATION OF ECOLOGICAL BALANCE. THE FINAL USE OF THE HEREIN DECLARED AGRICULTURAL LANDS SHALL NOT IN ANY WAY PREJUDICE ECOLOGICAL BALANCE. THE REMOVAL OF TREES AND OTHER TIMBER PRODUCTS THEREIN SHALL BE SUBJECT TO EXISTING FORESTRY LAWS AND REGULATIONS.":
- 2. On the same page and line, between the words "SEC. 2" and "Within", insert the sub-title "IMPLEMENTING RULES AND REGULATIONS";
- 3. On the same page, line 19, after the word "Resources", insert the punctuation mark comma "," and the phrase "IN COORDINATION WITH THE LOCAL GOVERNMENT OF DINALUPIHAN AND HERMOSA, PROVINCE OF BATAAN,"
- 4. On the same page, line 21, before Section 3, insert a new section which shall read as follows:
 - "SEC. 5. REPEALING CLAUSE. ALL LAWS, DECREES, EXECUTIVE ORDERS AND OTHER EXECUTIVE ISSUANCES WHICH ARE INCONSISTENT WITH OR CONTRARY TO THE PROVISIONS OF THIS ACT ARE HEREBY DEEMED REPEALED OR MODIFIED ACCORDINGLY."; and
- 5. Renumber the sections accordingly.

SEC. 2. Within sixty (60) days from the effectivity of this Act, the Secretary of the Department of Environment and Natural Resources shall issue the necessary rules and regulations for the effective implementation of this Act.

SEC. 3. This Act shall take effect fifteen (15) days after its publication in the Official Gazette or in a national newspaper of general circulation.
