





AN ACT CONVERTING THE LAKEVIEW ELEMENTARY SCHOOL
AND THE PEDRO E. DIAZ HIGH SCHOOL – LAKEVIEW ANNEX
IN BARANGAY PUTATAN, CITY OF MUNTINLUPA, METRO
MANILA INTO AN INTEGRATED SCHOOL TO BE KNOWN AS
LAKEVIEW INTEGRATED SCHOOL AND APPROPRIATING
FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. The Lakeview Elementary School and the Pedro E. Diaz
2 High School – Lakeview Annex in Barangay Putatan, City of Muntinlupa,
3 Metro Manila are hereby converted into an integrated school to be known as
4 *Lakeview Integrated School.*

5 SEC. 2. All personnel, assets, liabilities' and records of the Lakeview
6 Elementary School and the Pedro E. Diaz High School – Lakeview Annex are
7 hereby transferred to and absorbed by the Lakeview Integrated School.

8 SEC. 3. The Secretary of Education shall immediately include in the
9 Department's program the operationalization of the Lakeview Integrated
10 School, the funding of which shall be included in the annual General
11 Appropriations Act.

1 **SEC. 4.** The Secretary of Education shall issue the rules and regulations
2 necessary to carry out the purpose of this Act.

3 **SEC. 5.** This Act shall take effect fifteen (15) days after its publication
4 in the *Official Gazette* or in a newspaper of general circulation.
