


The Committees on Health and Demography and Finance, to which were referred House Bill No. 1001, introduced by Rep. Barcelona-Reyes entitled:

AN ACT PROVIDING FOR THE ESTABLISHMENT OF A DISTRICT HOSPITAL IN THE MUNICIPALITY OF SANTA ELENA, PROVINCE OF CAMARINES NORTE AND APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:*

1           SECTION 1. There shall be established, under the supervision of the  
2 Department of Health, a district hospital in the Municipality of Santa Elena,  
3 Province of Camarines Norte to be known as the Santa Elena District Hospital.

4           SEC. 2. The Department of Health shall issue the necessary rules and  
5 regulations for the effective implementation of this Act.

6           SEC. 3. The amount necessary for the implementation of this Act shall  
7 be charged to the appropriations of the Department of Health under the current  
8 General Appropriations Act. Thereafter, such amount as may be necessary for  
9 the operation and maintenance of the hospital shall be included in the annual  
10 budget of the local government concerned.

11           SEC. 4. This Act shall take effect fifteen (15) days after its publication  
12 in the *Official Gazette* or in a newspaper of general circulation.
