AN ACT INCREASING THE BED CAPACITY OF THE ROSARIO DISTRICT HOSPITAL IN THE MUNICIPALITY OF ROSARIO, PROVINCE OF LA UNION FROM TWENTY-FIVE (25) TO FIFTY (50) BEDS AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. The authorized bed capacity of the Rosario District Hospital in the Municipality of Rosario, Province of La Union is hereby increased from twenty-five (25) to fifty (50) beds.

SEC. 2. The existing hospital facilities and professional health care services of the Rosario District Hospital shall, as far as practicable, be correspondingly upgraded to include the increase in the number of medical personnel. The Department of Health, in coordination with the concerned local government officials, shall promulgate the necessary rules and regulations for the effective implementation of this Act.

1	SEC. 3. The increase in bed capacity of the Rosario District Hospita						
2	from twenty-five (25) to fifty (50) shall be implemented for a period of no						
3	more than two (2) years from the approval of this Act.						
4	SEC. 4. The Provincial Government of La Union shall provide the						
5	necessary funds to support the increase in bed capacity of the Rosario District						
6	Hospital and the corresponding upgrading of its facilities and services. The						
7	Secretary of Health shall include in the Department's subsidy program its						
8	support for the capital outlay requirements of the hospital.						
9	SEC. 5. This Act shall take effect fifteen (15) days after its publication						
10	in the Official Gazette or in a newspaper of general circulation.
