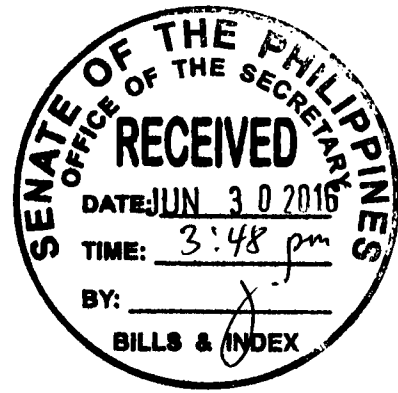

INCREASING THE QUARTERS ALLOWANCE OF OFFICERS AND ENLISTED
PERSONNEL OF THE ARMED FORCES OF THE PHILIPPINES AND FOR
OTHER PURPOSES

EXPLANATORY NOTE

The current quarters allowance of the officers and enlisted personnel of the Armed Forces of the Philippines (AFP) is as follows:

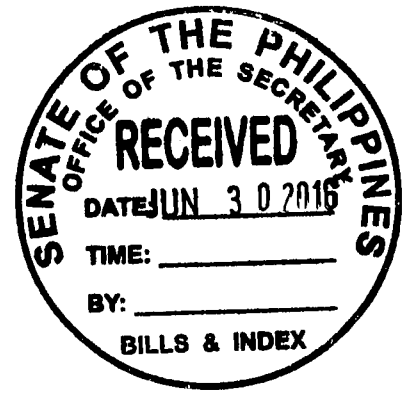

**AN ACT
INCREASING THE QUARTERS ALLOWANCE OF OFFICERS AND ENLISTED
PERSONNEL OF THE ARMED FORCES OF THE PHILIPPINES AND FOR
OTHER PURPOSES**

*Be in enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 **SECTION 1.** It is hereby declared the policy of the State to promote professionalism
2 in the Armed Forces of the Philippines (AFP) and to provide adequate remuneration and
3 benefits to its members. Pursuant thereto, the government shall provide adequate support and
4 incentives to the members of the Armed Forces.

5
6 **SEC. 2.** The officers and enlisted personnel of the AFP shall be provided with
7 housing facilities consistent with the requirements of the service. Allowances per capita shall
8 be provided for all officers and enlisted personnel to attain this objective. Such allowances
9 may be commuted if no housing facilities can be made available.

11 **SEC. 3.** In order to upgrade the morale of the AFP, the quarters allowance for married
12 officers and enlisted personnel shall be adjusted in accordance with the following rate:

22 **SEC 4.** To finance the amount necessary to carry out the provisions of this Act, the
 23 funds to be allocated shall be charged against the following sources:

24 1.) Fifty percent (50%) of the net government share in the proceeds of service
 25 Contract No. 38 authorized under Sec. 8 of P.D. 910 (Malampaya Funds);

26 2.) Twenty percent (20%) of the annual share of the AFP Modernization program
 27 on the income derived from the leases, joint ventures and other similar transactions on
 28 properties in Metro Manila entered into by the BCDA as mandated under EO 309;

29 3.) Annual saving of the Department of National Defense and the Armed Forces
 30 of the Philippines; and

1 4.) The miscellaneous personnel benefits funds

2 Such amount as maybe necessary to fund the quarters allowance under this Act is
3 hereby authorized to be automatically set aside from the said fund sources for this
4 purpose. Any deficiency in the financial requirement shall be covered by the annual
5 appropriations passed by Congress. Provided, however, that for the initial year of
6 implementation of this act, such appropriation shall commence on the third quarter of
7 the fiscal year;

8
9 **SEC. 5.** The Secretary of National Defense shall promulgate rules and regulations for
10 the effective implementation of this Act.

11 **SEC. 6.** Provisions of Republic Act No. 7227, as amended by Republic Act No. 7917,
12 Executive Order No. 309 (s. 2000), Presidential Decree No. 910 and all other laws, decrees,
13 executive orders, rules and regulations inconsistent with this Act, are hereby repealed,
14 amended or modified accordingly.

16 **SEC. 7.** This Act shall take effect fifteen (15) days following its complete publication
17 in the Official Gazette or in two (2) national newspapers of general circulation.
