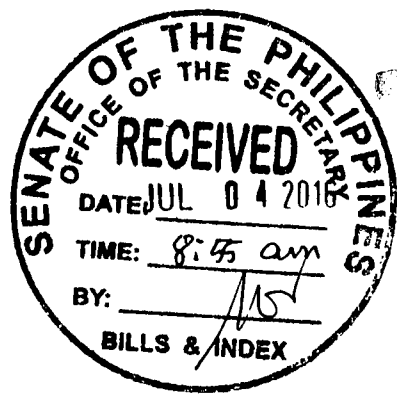

EXPLANATORY NOTE

The improvement of the Philippine Air Force's (PAF) regular officer delivery system has been an impending need of the military establishment.

The PAF Flying Schools (PAFFS), which is at present the main source of regular officers in the PAF, could no longer provide the required number and proper training of officer pilots because of inadequate facilities and logistical support.

More so, since a college degree is an academic requirement for entrance into the PAFFS, thousands of poor high school graduates with great potentials are denied from joining the PAF because they have no financial support for a college education.


The creation of the Philippine Air Force Academy (PAFA) shall address this problem in line with the constitutional mandate of guaranteeing equal access of opportunity for public service.

Given the inherent political instability of a developing country such as the Philippines, we should ensure that our systems do not espouse an unwanted relationship among officers often called "regular officer homogeneity". Concerned sectors believed that this "officer homogeneity" may endanger a potentially explosive political situation where all the branches and levels of the Armed Forces are controlled by a regular-officer school. The creation of the PAF will help preclude this situation.

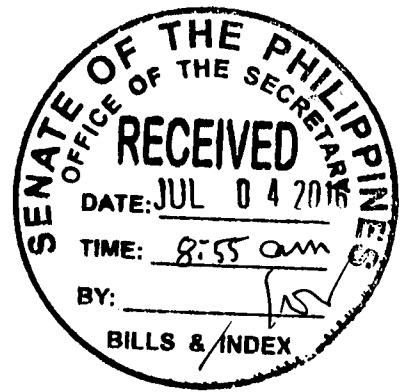
There is also a need to professionalize other officer career areas of the Air Force such as the aircraft maintenance, avionics and air logistics to further enhance the efficiency and effectiveness of the PAF. These highly specialized career fields could not be provided adequately by a traditional military academy such as the Philippine Military Academy.

The PAF Academy as conceptualized, is geared towards making available an adequate and dedicated corps of professional Air Force officers with the proper education, training and orientation to lead and manage the complex technologies inherent in the field of aviation.

For these foregoing reasons, the approval of this bill is earnestly requested.

AN ACT
ESTABLISHING THE PHILIPPINE AIR FORCE ACADEMY (PAFA) AND
APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress Assembled:

1 SECTION 1. *Philippine Air Force Academy* - There shall be established in the
2 Philippine Air Force an educational institution to be known as the Philippine Air Force
3 Academy (PAFA), hereinafter referred to as the Academy, for the instruction and preparation
4 for military service of Air Force Cadets.

5 SECTION 2 *Administration* - The academy as herein established shall be organized
6 and administered by the Commanding General Philippine Air Force (PAF) under the general
7 supervision and control of the Chief of Staff of the Armed Forces of the Philippines.

8 SECTION 3. *Academic Board* - The Academic Board of the Academy shall be
9 composed of the Superintendent, the Dean of the Corps of Professors, the Commandant of
10 Cadets and the Heads of the departments to be constituted as follows:

11 a) The Superintendent and the Commandant of Cadets of the Academy shall be
12 detailed to those positions by the President from the Officers of the Air Force.

13 b) The Dean of the Corps of Professors shall be appointed from the permanent
14 professors who have served as heads of departments of instructions at the Academy.

15 c) The Academic Board shall have the power to confer the degree of Bachelor of
16 Science under the rules and regulations as the Chief of Staff of the Armed Forces of the
17 Philippines may prescribe upon all cadets who may hereafter satisfactorily complete the
18 approved course of studies.

1 SECTION 4. *Department Title and Faculty* - The Chief of Staff of the Armed Forces
2 of the Philippines may prescribe the title of each of the departments of instruction and
3 professors of the Academy. However, each change of the title of the department or professor
4 shall not affect the status, rank or eligibility for promotion or retirement of, or otherwise
5 prejudice, a professor of the Academy.

6 SECTION 5. *Cadet Corps of the Philippine Air Force* - The student body of the
7 Academy shall be known as the Cadet Corps of the Philippine Air Force (CCPAF). The
8 President is authorized to appoint annually, subject to such physical and mental examinations
9 as may be prescribed, the number of cadets necessary to maintain the Cadet Corps at a
10 strength as may be determined by the Academic Board.

11 The Academy shall provide for educational and physical facilities for the recruitment
12 and training of women as member of Cadet Corps.

13 All cadets shall be appointed by the President. An appointment is conditional until the
14 cadet is admitted.

15 SECTION 6. *Eligibility for Admission* - To be eligible for admission, a candidate
16 must be:

- 17 1) Single
- 18 2) A natural born citizen of the Philippines;
- 19 3) At least seventeen (17) years of age but not more than twenty two (22) years of
20 age on the first day of April of the year of admission;
- 21 4) At least high school graduate;
- 22 5) A successful examinee of the prescribed physical and mental examination; and
- 23 6) A successful examinee of the National Secondary Assessment Test.

24 SECTION 7. *Pay and Allowances* - The pay and allowances of the Cadets of the
25 Academy shall be fixed by the President.

26 SECTION 8. *Undertaking* - Each cadet shall sign an agreement that unless sooner
27 separated by duly authorized, authority, he shall

- 28 1) Complete the course of instruction at the Academy;

1 2) Accept an appointment and serve as a commissioned officer of the Armed Forces
2 of the Philippines for at least eight years immediately after graduation from the
3 Academy.

4 SECTION 9. *Cadet requirement* - Any Cadet who shall after entrance to the Academy
5 and before completion of the prescribed courses of training, be found physically and mentally
6 unfit for military assignment by reason of injury or disease incident to the service, shall be
7 retired with the rank of second lieutenant of the Armed Forces of the Philippines.

8 SECTION 10. *Prohibition Against Hazing* - Subject to the approval of the Secretary of
9 the National Defense, the Superintendent of the Academy shall issue rules and regulations
10 preventing hazing and prescribe dismissal suspension and other adequate punishment for
11 violation thereof.

12 For the purpose of this Act "hazing" means any unauthorized assumption of authority
13 by a cadet whereby another cadet suffers or is exposed to any form of injury, indignity,
14 humiliation, hardship or oppression or the deprivation or abridgement of any right.

15 If a cadet is charged with violating any rule or regulation issued pursuant to this
16 section, the penalty of which is dismissal from the Academy, a request in writing for a trial by
17 a general court martial may be submitted.

18 A cadet dismissed from the Academy for hazing shall not be reappointed as an Air
19 Force Cadet and shall be ineligible for appointment as a commissioned officer in the Armed
20 Forces of the Philippines unit after two (2) years from the graduation of the class.

21 SECTION 11. *Commission* - Upon satisfactory completion of the course of
22 instruction at the Academy, the Cadets shall be commissioned second lieutenants in the
23 regular force of the Philippine Air Force with the relative rank in the order of final general
24 standing as determined by the Academic Board of the Academy and approved by the Chief of
25 Staff of the Armed Forces of the Philippines.

26 SECTION 12. *Transfer of Assets and Liabilities* - The Philippine Air Force Flying
27 School, including the members of its faculty and personnel, its records, equipment, assets and
28 liabilities are hereby transferred to and integrated with the Philippine Air Force Academy.

1 SECTION 13. *Budget* - The initial appropriations necessary for the establishment of
2 the Academy shall be charged to the appropriation of the Department of National Defense.
3 Thereafter, the amount necessary for the improvement, operation and maintenance of the
4 Academy shall be included in the Annual General Appropriations Act.

5 SECTION 14. *Effectivity* - This Act shall take effect upon approval.
