AN ACT

TO ENHANCE TRANSPARENCY AND ETHICS IN THE JUDICIARY BY ESTABLISHING AN OFFICE OF INSPECTOR GENERAL FOR THE JUDICIAL BRANCH, DEFINING ITS POWERS AND FUNCTIONS, APPROPRIATING FUNDS THEREFOR, AND FOR OTHER PURPOSES

EXPLANATORY NOTE

Article VIII, Section 3 of the 1987 Constitution articulates that a member of the Judiciary must be a person of proven competence, integrity, probity, and independence. Furthermore, Article II Section 27 of the same provides that the State shall maintain honesty and integrity in the public service and take positive and effective measures against graft and corruption. However, recent surveys show the growing salience of members of the judiciary who circumvent the aforementioned law, thus, compromising the integrity and reputation of the country's judicial system.

According to Transparency International's Bribe Payers Index 2008, companies' confidence in the judicial system in the Philippines is low due to allegations of graft and corruption, as well as incompetence within the judiciary. The US Department of State in 2012 also shares the same view, where many foreign investors cite the judicial system in the Philippines as insufficient and uncertain, due to corruption and understaffing, significantly hindering investment. Further, bribery allegations reflected in different newspapers in the country in 2009 involving the so called "Alabang Boys" wherein P50 Million in bribes were allegedly paid to prosecutors and' officials in the Department of Justice (DOJ) for the release of the 3 drug suspects strengthens the above observations of corruption in the Judiciary.

There is therefore an exigency for the government to swiftly pursue appropriate judicial reforms, and mere out appropriate penalties against erring magistrates. "A perception of corruption within the judiciary undermines its ability to enforce and maintain the legitimacy of the rule of law, which subsequently undermines the stability and effectiveness of the government and prevents economic development of the State.

In this light, this measure seeks to establish mechanisms for the detection and prevention of (1) inappropriate judicial conduct, (2) illegal activity, (3) actions that undermine the judicial machinery, and (4) violations of the Code of Ethics. This measure shall create an Office of the Inspector General and shall require the Office to: (1) conduct investigations of alleged

misconduct in the Judicial branch; (2) conduct and supervise audits and investigations; and (3) prevent and detect waste, fraud, and abuse. The bill shall also provide for whistle-blower protection. It is hoped that this measure will finally put a halt to judicial abuses that prevent our legal machinery from working in its proper course.

In view of the foregoing, immediate approval of this measure is earnestly sought.

AN ACT

TO ENHANCE TRANSPARENCY AND ETHICS IN THE JUDICIARY BY ESTABLISHING AN OFFICE OF INSPECTOR GENERAL FOR THE JUDICIAL BRANCH, DEFINING ITS POWERS AND FUNCTIONS, APPROPRIATING FUNDS THEREFOR, AND FOR OTHER PURPOSES

Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:

1	SECTION 1. Short Title. – This Act shall be known as the "Judicial Transparency
2	and Ethics Enhancement Act".
3	
4	SEC. 2. Establishment There is established for the judicial branch of the
5	government the Office of Inspector General for the Judicial Branch, hereinafter referred to as
6	the "Office".
7	
8	SEC. 3. Appointment, Term, and Removal of Inspector General. –
9	
10	a) Appointment - The head of the Office shall be the Inspector General, who shall
11	be appointed by the Chief Justice.
12	b) Term - The Inspector General shall serve for a term of four (4) years and may be
13	reappointed by the Chief Justice for any number of additional terms.
14	c) Removal - The Inspector General may be removed from office by the Chief
15	Justice. The Chief Justice shall communicate the reasons for any such removal to
16	both Houses of Congress.

1	SEC. 4. Duties With respect to the judicial branch, the Office shall –
2	
3	1. Conduct investigations of alleged misconduct in the judicial branch (other than
4	the Supreme Court), that may require oversight or other action within the judicial
5	branch or by Congress;
6	2. Conduct investigations of alleged misconduct in the Supreme Court, that may
7	require oversight or other action within the judicial branch or by Congress;
8	3. Conduct and supervise audits and investigations;
9	4. Prevent and detect waste, fraud, and abuse; and
10	5. Recommend changes in laws or regulations governing the judicial branch.
11	
12	SEC. 5. Powers and Limitations. –
13	a) Powers - In carrying out the duties of the Office, the Inspector General shall have
14	the power to:
15	
16	1. Make investigations and reports;
17	2. Obtain information or assistance from any national or local governmental
18	agency, or other entity, or unit thereof, including all information kept in
19	the course of business by the Judicial and Bar Council, and the Integrated
20	Bar of the Philippines;
21	3. Require, by subpoena or otherwise, the attendance and testimony of such
22	witnesses, and the production of such books, records, correspondence
23	memoranda, papers, and documents, which subpoena, in the case of
24	contumacy or refusal to obey, shall be enforceable by civil action;
25	4. Administer to or take from any person an oath, affirmation, or affidavit;
26	5. Employ such officers and employees, governing appointments in the
27	competitive service; and
28	6. The extent and in such amounts as may be provided in advance by
29	Appropriations Acts, to enter into contracts and other arrangements for
30	audits, studies, analyses, and other services with public agencies and with
31	private persons, and to make such payments as may be necessary to carry
32	out the duties of the Office.

1	b) Limitations - The Inspector General shall not have the authority to –
2	
3 ′	1. Investigate or review any matter that is directly related to the merits of a
4	decision or procedural ruling by any judge, justice, or court; or
5	2. Punish or discipline any judge, justice, or court.
6	
7	SEC. 6. Reports. –
8	
9	a) When to be Made - The Inspector General shall-
10	1. Make an annual report to the Chief Justice and to Congress relating to the
11	activities of the Office; and
12	2. Make prompt reports to the Chief Justice and to Congress on matters that
13	may require action by the Chief Justice or Congress.
14	
15	b) Sensitive Matter - If a report contains sensitive matter, the Inspector General may
16	so indicate and Congress may receive that report in closed session.
17	
18	c) Duty To Inform Attorney General - In carrying out the duties of the Office, the
19	Inspector General shall report expeditiously to the Attorney General whenever the
20	Inspector General has reasonable grounds to believe there has been a violation of
21	Federal criminal law.
22	
23	SEC. 7. Whistleblower Protection
24	
25	(a) In General - No officer, employee, agent, contractor or subcontractor in the
26	judicial branch may discharge, demote, threaten, suspend, harass or in any other
27	manner discriminate against an employee in the terms and conditions of employment
28	because of any lawful act done by the employee to provide information, cause
29	information to be provided, or otherwise assist in an investigation regarding any
30	possible violation of law or regulation, or misconduct, by a judge, justice, or any other
31	employee in the judicial branch, which may assist the Inspector General in the
32	performance of duties under this chapter.

(b) Civil Action - An employee injured by a violation of subsection (a) may, in a civil action, obtain appropriate relief.

4 SEC. 8. *Separability Clause.* - If any provision or part hereof is held invalid or 5 unconstitutional, the remainder of the law or the provision not otherwise affected shall remain 6 valid and subsisting.

8 SEC. 9. *Repealing Clause.* - Any law, presidential decree or issuance, executive 9 order, letter of instruction, administrative order, rule or regulation contrary to, or inconsistent 10 with, the provisions of this Act, is hereby repealed, modified, or amended accordingly.

SEC. 10. *Effectivity Clause.* - This Act shall take effect fifteen (15) days after its
complete publication in the Official Gazette or in at least two (2) newspapers of general
circulation.
