GRANTING HAZARD PAY TO COVERED EMPLOYEES OF THE GOVERNMENT AND APPROPRIATING FUNDS THEREFOR

EXPLANATORY NOTE

In the past, a number of government employees have been harmed, and worse, killed in pursuance of their duties. More often than not, the families of the deceased have been unable to afford their departed relatives a decent burial, to say the least. Thus, it is only fitting that they be provided compensation for the risks connected with their duties.

This bill is being proposed in order to provide all officials and employees of the government a hazard pay especially in cases where they are assigned to hazardous, isolated and inaccessible areas, x-ray units, institutions that care for the mentally deranged, places that are subject to depredation by criminal elements, plants and installations of the arsenal, aboard aircrafts and watercrafts in crossing bodies of water and other similar situations.

In view of the foregoing, the immediate passage of this measure is earnestly requested.

AN ACT

GRANTING HAZARD PAY TO COVERED EMPLOYEES OF THE GOVERNMENT AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:

SECTION 1. Declaration of Policy. - It is hereby declared the policy of the State to 1 protect and promote the welfare of public servants by providing them with additional 2 compensation taking into account the nature of the responsibilities pertaining to their 3 4 positions. 5 6 SEC. 2. Hazard Pay. - All employees and officials of the Government shall be paid 7 when stationed or assigned to work in or under the following circumstances/conditions: 8 9 a) Hazardous or less hazardous areas that may be declared as such by the Secretary 10 of National Defense; 11 b) Difficult areas of hardship posts characterized by distance, inconvenience of travel 12 13 due to bad roads and conditions of the terrain, isolation, inaccessibility and 14 extreme weather conditions: 15 16 c) X-ray units, clinics, laboratories, sanitaria, leprosaria and other similar stations 17 which offer risks to health and safety due to exposure to radiation, contagious 18 diseases and volcanic activity; 19 20 d) Institutions that tend or care for mentally-deranged patients; 21 e) Places that are subject to depredation by criminal elements as those in prison 22 reservations and penal colonies without adequate police protection; 23 24 25 f) Plants and installations of the arsenal; 26 27 g) Aboard aircraft and watercraft in crossing bodies of water; and 28 29 h) Other similar work conditions which the Department of Budget and Management (DBM) shall consider hazardous on the basis of exposure to environment, health 30 31 and social risks. 32

1 SEC. 3. *Coverage.* - The benefits provided herein are payable to all officials and 2 employees who have rendered at least one (1) year of continuous and faithful government 3 service.

5 **SEC. 4.** *Rules and Regulations.* - The DBM shall issue the necessary rules and 6 regulations to implement the provisions of this Act. 7

8 SEC 5. *Funding.* - The funds to implement this Act shall be included in the General
9 Appropriations Act.

11 SEC. 6. *Effectivity.* - This Act shall take effect fifteen (15) days after its publication 12 in the Official Gazette or in at least two (2) national newspapers of general circulation 13 whichever comes earlier
