AN ACT INSTITUTING A DRIVER EDUCATION PROGRAM PROVIDING THE IMPLEMENTING MECHANISMS THEREFOR AND FOR OTHER PURPOSES

EXPLANATORY NOTE

We see and hear in the media everyday damages to lives and propelties caused by vehicular accidents and mishaps, accidents that may have been prevented if the person behind the wheel had enough discipline and courtesy while driving. Sadly however, most of the drivers who have the privilege to drive display a lack of discipline to handle the wheel as evidenced by traffic altercations and everyday traffic jams.

Proper driving courtesy and discipline may be acquired if one enrolls ill formal driving schools. However, enrolling in a driver school to most drivers is not an option because it proves to be costly, thus they learn how to drive from friends and relatives who themselves were not properly educated in formal driving schools.

This bill seeks to introduce a Driver Education Program in the curriculum of high schools in both public and private to instill into the minds of the students as early, and as young as possible, the proper knowledge and values in driving.

In view of the foregoing, immediate approval of this measure is earnestly sought.

AN ACT

INSTITUTING A DRIVER EDUCATION PROGRAM PROVIDING THE IMPLEMENTING MECHANISMS THEREFOR AND FOR OTHER PURPOSES

Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:

SECTION 1. Short Title. - This Act shall be known as the "Driver Education Act of 2016."

SEC. 2. Declaration of Policy. - The State is mandated to promote a just and dynamic social order, which is anchored mainly on the vision of ensuring the prosperity of the nation that could provide the people a rising standard of living, and an improved quality of life for all. No better place to see a just and dynamic social order than on the roads that are safe and secure.

SEC. 3. Scope and Application. - The provisions of this Act shall apply to all high schools, public or private, nationwide.

SEC. 4. Instituting a Driver Education Program - All high schools, public or private, nationwide are required to integrate lectures on driver education in existing subjects where the same may be applicable.

SEC. 5. Task Force on the Program. - The Department of Education (DepEd) and Land Transportation Office (LTO) shall create a task force that shall establish the minimum requirements for driver education student curricula, which shall be certified by the Assistant Secretary of LTO.

All curricula shall be reviewed by the task force every five (5) years to assure that they are relevant.

SEC 6. Curricula of the Program. - The cunicula of the program shall include, but not limited, to the following:

Implementing Agency. - Once approved, the Department of Education will be the main implementing agency of this Act. 9 10 11 SEC. 9. Implementing Rules and Regulations (IRR). - Immediately upon the approval of this Act, the Department of Education and the Land Transportation Office shall 12 promulgate the implementing rules and regulations of this Act. 13 14 15 SEC. 10. Separability Clause. - If any provisions, or part hereof, is held invalid or unconstitutional, the remainder of the law of the provision not otherwise affected shall remain 16 valid and subsisting. 17 18 19 SEC. 11. Repealing Clause. - All laws, decrees, executive orders, rules and regulations inconsistent with this Act, are hereby repealed, amended or modified accordingly. 20 21 22 SEC. 12. Effectivity Clanse. - This Act shall take effect fifteen (15) days following its complete publication in the Official Gazette or in two (2) national newspapers of general 23 24 circulation.
