PARLIAMENTARY INQUIRY OF SENATOR PANGILINAN

For purposes of determining the proportionate representation in the different committees as provided for in the Rules of the Senate, Senator Pangilinan asked how many members constituted the Majority and the Minority, respectively.

In reply, Senate President Pimentel informed the Body that as intimated to him by Senator Zubiri, Senator Cayetano would like to be counted in the Majority for purposes of the distribution of committee membership. Thus, he said that using a given formula, 21 members belonging to the Majority multiplied by 0.875 would give the number of seats for the Majority, and three members of the Minority multiplied by 0.125 would give the number of seats for the Minority for each committee.

Senator Pangilinan thanked Senate President Pimentel for the clarification, noting the earlier quandary as to the membership of Senator Cayetano.

Senate President Pimentel said that if necessary, corrections would be done to previously constituted committees to be reflected in the Journal.

### MANIFESTATION OF SENATOR RECTO

Senator Recto appealed for liberality in favor of Minority representation in the committees when using the formula in determining proportionate representation. For instance, if, after computation, the figure arrived at is 1.4 for the Minority, he asked that it be rounded off to two since anyway there are only three of them constituting the Minority. Senate President Pimentel took note of the appeal and referred it to the Majority Leader for appropriate action.

Senator Sotto asked that the concern of Senator Recto be referred directly to the Committee on Rules to be taken up on or before Monday.

There being no objection, Senate President Pimentel referred the appeal of Senator Recto to the Committee on Rules.

Asked by Senate President Pimentel whether the nomination of members to the Committee on Finance would be affected by the appeal of Senator Recto, Senator Sotto answered in the negative.

### RESUMPTION OF SESSION

At 5:06 p.m., the session was resumed.

Upon resumption, Senator Sotto clarified that earlier, with the concurrence of Senator Recto, Senator Cayetano was nominated for membership to the Committee on Labor, Employment and Human Resources Development, occupying the seat reserved for Senator Trillanes who waived his right in favor of the Majority.

Senator Recto explained that it was in keeping with the principle of liberality as earlier mentioned.

### PARLIAMENTARY INQUIRY OF SENATOR DRILON

Senator Drilon asked the Committee on Rules if the Minority could nominate somebody from the Majority to represent the Minority. Senator Sotto replied that it was indeed unusual but he clarified that it was the committee chairman himself who manifested the change.

Senator Drilon pointed out, however, that membership in a committee is voted upon by the Chamber as a whole and that the committee chair could only nominate the members. Consequently, he expressed very serious reservation to the substitution of Senator Cayetano in lieu of Senator Trillanes.

At this juncture, Senator Pangilinan suggested that the issue raised by Senator Drilon be referred to the Committee on Rules considering that memberships in the committees based on proportionate representation are determined by the Rules and not by the Body. He added that should the Body wish to amend the Rules by allowing adjustments in the representation, then it should be the direction that the Body should take.

Senator Recto clarified that it was the chair of the Committee on Labor, Employment and Human Resources Development who requested him to give the slot of the Minority to the Majority and that he was only being cooperative in giving in to such a request.

Senator Drilon stated that he appreciated the magnanimity of the Minority in giving up its representation, but he cautioned that it could lead to some problems.

Senator Sotto withdrew his motion to elect Senators Cayetano and Escudero as members of the Committee on Labor, Employment and Human Resources Development.

### MANIFESTATION OF SENATE PRESIDENT PIMENTEL

Senate President Pimentel clarified that it was the Majority which was actually making a motion for the Minority to give up one seat, a motion that the Minority accommodated. Senator Drilon believed that when a member of the Majority is nominated to take the seat reserved for the Minority, the Majority member would henceforth represent the Minority in the committee.

Senate President Pimentel stated that in the filling up of memberships in the committees, a mathematical ratio is being followed as a guide, and there should be no issue if the Minority does not mind that the formula is not strictly followed.

Senator Pangilinan expressed concern that such an arrangement would create problems since nothing would stop other committees and chairpersons from applying the same.

Senate President Pimentel, however, opined that such arrangement could be stopped by an objection from the Minority especially if the membership ratio would be too distorted. He suggested that the Committee on Rules study the matter in depth.

Senator Sotto assured that the Committee on Rules would take into account all the manifestations made by the senators and by Senate President Pimentel.
