AN ACT  
REGULATING THE PRACTICE OF FISHERIES PROFESSION IN THE  
PHILIPPINES, CREATING FOR THE PURPOSE A PROFESSIONAL  
REGULATORY BOARD OF FISHERIES AND APPROPRIATING FUNDS  
THEREFOR

EXPLANATORY NOTE

This measure seeks to professionalize and regulate the practice of fisheries professionals and upgrade the standard of fisheries education in the country through the licensure examination being administered by the Professional Regulatory Commission (PRC). This intent is provided for in Republic Act 8550 (Fisheries Code of 1998) and Republic Act 8435 (Agriculture and Fisheries Modernization Act of 1997) – that, it is the policy of the state to provide priority attention and support to professionalize the practice of fisheries profession in the Philippines which will be beneficial to sustain food security and economic development of the country, and to upgrade the standard of fisheries education. Through its licensure examination, the PRC is complimenting the effort of the CHED in upgrading the standard of fisheries education.

The bill provides for the following: the scope of the practice of the fisheries profession; mandates continuing professional education and development of fisheries professionals for global competitiveness; provides penal provisions for violation of its mandatory provisions; encourages the hiring of licensed fisheries professionals; determines the composition, tenure and qualifications of the fisheries regulatory board; and empowers the board of fisheries to regulate compliance by private and public institutions to the provisions of this Act.

Throughout the country, candidates for the licensure examination of the PRC come from more than 80 fishery schools. These schools vary widely in terms of their resources (faculty and facilities), curricular offerings, and amounts of budget support from the government. Many of these schools started as high schools and were later converted to college. They continued offering fisheries courses without upgrading their facilities and employed practically the same faculty, many of whom were not trained for college teaching.

Thus, it is imperative to screen and standardize the quality of fisheries graduates; regulate the practice of fisheries profession throughout the country; and prevent the practice of foreign professionals without permit.

In view of the foregoing, the immediate passage of this bill is earnestly sought.

AN ACT  
REGULATING THE PRACTICE OF FISHERIES PROFESSION IN THE  
PHILIPPINES, CREATING FOR THE PURPOSE A PROFESSIONAL  
REGULATORY BOARD OF FISHERIES AND APPROPRIATING FUNDS  
THEREFOR

Be it enacted by the Senate and the House of Representatives of the Philippines in  
Congress assembled:

ARTICLE I  
TITLE, DECLARATION OF POLICY, OBJECTIVES AND DEFINITION OF  
TERMS

SECTION 1. *Short Title.* – This Act shall be known as the “*The Philippine  
Fisheries Profession Act of 2016*”.

SEC. 2. *Declaration of Policy.* – It is hereby declared the policy of the State to  
provide priority attention and support to professionalize the practice of the fisheries  
profession in the Philippines, which will be beneficial to sustain food security and economic  
development of the country, and to upgrade the standards of fisheries education. These  
policies are provided for in Republic Act 8550 (Fisheries Code of 1998) and Republic Act  
8435 (Agriculture and Fisheries Modernization Act of 1997).

Pursuant to this national policy, the government shall: (1) provide a program to set up  
an appropriate and healthy environment to the practice of the fisheries profession; and (2)  
establish quality standards for fisheries professionals that will guide fisheries schools /  
fisheries colleges, through the Commission on Higher Education (CHED), for the  
development of curricular programs that will attain the high standards of the profession.

- SEC. 3. *Objectives.* – The Act provides for and shall govern:
- a. the administration and conduct of licensure examination, and registration and  
licensing of fisheries professionals;
  - b. the supervision and regulation of the practice of the fisheries profession in the  
Philippines; and
  - c. the upgrading of the fisheries profession and the professionalization of fisheries  
professionals.

1           **SEC.4. *Definition of Terms.*** – For purposes of this Act, the following terms shall  
2 mean:

- 3           a. Aquaculture – refers to fishery operations involving all forms of farming fish and  
4           other aquatic plants and animals in fresh, brackish, and marine waters;  
5  
6           b. Aquatic Resources – shall include fish and other living resources of the aquatic  
7           environment that have/will have commercial value when utilized;  
8  
9           c. Board – refers to the Professional Regulatory Board of Fisheries;  
10  
11          d. Commission – refers to the Professional Regulation Commission;  
12  
13          e. Fisheries – refers to all activities relating to the science and act or business of  
14          fishing, culturing, preserving, processing, marketing, developing, conserving and  
15          managing of aquatic resources and environment;  
16  
17          f. Fisheries Sector – refers to the sector engaged in the production, growing,  
18          harvesting, processing, marketing, developing, conserving and managing of  
19          aquatic resources and environment;  
20  
21          g. Fisheries Profession – the practice of the science and technical knowledge and  
22          skills of all areas of fisheries (catching, farming, processing, marketing,  
23          management, and conservation of aquatic resources and environment);  
24  
25          h. Fisheries Professional – refers to a person who is technically qualified and  
26          competent to practice the fisheries profession and who has been issued a  
27          certificate of registration and professional identification card as fisheries  
28          professional by the Board and the Commission;  
29  
30          i. Accredited Professional Organization (APO) – refers to an integrated national  
31          organization, association, or society that is granted accreditation by the Board and  
32          the Commission as the Accredited Professional Organization of Fisheries  
33          Professionals; and  
34  
35          j. Scope of Examination – refers to the range of topics or subjects provided by the  
36          Board in the syllabi of the four areas of scope of examination for fisheries  
37          professionals in Section 9 (m) and 15 of this Act.  
38  
39

40           **SEC. 5. *Scope and Practice of the Fisheries Profession.*** – The scope and practice of  
41 the fisheries profession is the application of the fundamental and known principles of  
42 fisheries to the peculiar conditions and requirements of fisheries as an industry and as a field  
43 of science and shall include, but not be limited to the following:

- 44           a. Consultation, evaluation, investigation and management services in fisheries;  
45  
46           b. Preparation of fisheries designs, plans, specifications, project feasibility studies  
47           and estimates, and the supervision and other management services in the  
48           construction, installation, operation and maintenance of fishing vessels, farm and  
49           facilities, post-harvest equipment and facilities and other fisheries facilities,  
50           systems and technologies, in collaboration with other disciplines when needed;

- 1 c. Conduct of research and development, training and extension work in fisheries,  
2 aquatic resource, aquaculture and post-harvest technologies;  
3  
4 d. Management of fisheries resources and manufacture of fishery products, and/or  
5 marketing of fish and fishery products;  
6  
7 e. Teaching fisheries courses in higher institutions of learning in the Philippines  
8 recognized by the government;  
9  
10 f. Study and treatment of fish diseases and parasites that affect fishing, post-harvest  
11 and aquaculture activities and projects; and  
12  
13 g. Employment in the government and private sectors where the positions require  
14 the knowledge and expertise of a fisheries professional except in small-scale  
15 fisheries operations of municipal fisher folk such as fishing, aquaculture, fish  
16 processing where licensed fisheries professionals are not required.  
17

18 Scientists and professionals in closely related fields to fisheries and in support of  
19 multidisciplinary fisheries activities such as economics, social science, engineering, marine  
20 biology, oceanography/limnology and others who may immerse themselves in fisheries  
21 activities that do not require technical knowledge in fisheries, are exempted from the  
22 licensure requirements for fisheries professionals.  
23  
24

25 **ARTICLE II**  
26 **PROFESSIONAL REGULATORY BOARD OF FISHERIES**  
27

28 **SEC. 6. *Creation and Composition of the Professional Regulatory Board of***  
29 ***Fisheries.*** – There is hereby created a Professional Regulatory Board of Fisheries to be  
30 composed of a Chairman and three (3) Members to be appointed by the President of the  
31 Philippines from a list of three (3) recommendees of the Professional Regulation Commission  
32 for each position chosen from a list of five (5) nominees for each position submitted by the  
33 Accredited Professional Organization of fisheries professionals. The new Board shall be  
34 constituted within three (3) months from the effectivity of this Act.  
35

36 The Chairman and the three (3) Members of the Board must be registered professional  
37 fisheries technologists or fisheries professionals and issued with certificates of registration  
38 and professional identification cards at the time of their appointment.  
39

40  
41 **SEC. 7. *Qualifications of Board Members.*** – The Chairman and Members of the  
42 Board, at the time of their appointment, must possess the following qualifications:

- 43 a. Must be a natural-born citizen and resident of the Philippines;  
44  
45 b. Must be at least forty years of age;  
46  
47 c. Must be of proven integrity and of high moral and ethical values in his personal as  
48 well as professional conduct;

- 1 d. Must not have been convicted by a court in a final judgment in crime involving  
2 moral turpitude;  
3  
4 e. Must be a holder of a Bachelor's degree in the field of fisheries, or a holder of a  
5 Master or Doctorate degree in the field of fisheries from a school, college, or  
6 university recognized by the Government or abroad, and has been engaged in the  
7 practice of fisheries profession for at least ten (10) years before his/her  
8 appointment;  
9  
10 f. Must not be connected with any school, college or university granting a degree  
11 that qualifies graduates of such degree for admission to the licensure examination  
12 for fisheries professionals; and  
13  
14 g. Must not be an incumbent officer or trustee of the accredited professional  
15 organization for fisheries professionals.  
16  
17

18 **SEC. 8. Term of Office.** – The Chairman and Members of the Board shall hold office  
19 for a term of three (3) years or until their successors shall have been qualified and appointed.  
20 They may, however, be appointed for a second term. Any vacancy in the Board shall be filled  
21 for the unexpired portion of the term only. Each member shall take an oath of office prior to  
22 the assumption of duties.  
23

24 The incumbent Chairman and Members shall continue to serve until their  
25 replacements shall have been appointed and qualified.  
26  
27

28 **SEC.9. Powers and Functions of the Board.** – The Board shall have the following  
29 powers and functions:

- 30 a. Promulgate, adopt and issue rules and regulations to carry out the provisions of  
31 this Act;  
32  
33 b. Give and supervise the licensure examination for admission to the practice of the  
34 fisheries profession;  
35  
36 c. Supervise and regulate the licensure, registration and practice of the fisheries  
37 profession;  
38  
39 d. Administer the oath of a professional to the successful examinees in the licensure  
40 examination for fisheries professionals in appropriate mass oath-taking  
41 ceremonies to be held for the purpose;  
42  
43 e. Register and issue certificates of registration to successful examinees in licensure  
44 examinations for fisheries professionals and to persons qualified to register as  
45 fisheries professionals without examination;  
46  
47 f. Suspend or revoke the certificate of registration and professional identification  
48 card of a fisheries professional for causes provided herein;  
49  
50 g. Adopt an official seal of the Board as well as the seal of fisheries professionals;

- 1 h. Adopt and promulgate a Code of Ethics for Fisheries Professionals and a Code of  
2 Professional Standards for the Practice of the Fisheries Profession;  
3  
4 i. Look into the conditions affecting the practice of the fisheries profession and  
5 whenever necessary, adopt measures as may be deemed appropriate for the  
6 enhancement or maintenance of high professional and ethical standards of the  
7 practice of the fisheries profession;  
8  
9 j. Ensure, in coordination with the Commission on Higher Education (CHED), that  
10 all educational institutions offering courses in fisheries education comply with the  
11 policies, standards and requirements of the course prescribed by the CHED in the  
12 areas of curriculum, faculty, library and facilities;  
13  
14 k. Hear/try and decide administrative cases involving violations of the provisions of  
15 this Act and its Implementing Rules and Regulations including the Code of Ethics  
16 for Fisheries Professionals and Code of Professional Standards for the Practice of  
17 Fisheries Profession and, for this purpose, issue subpoena and subpoena *duces*  
18 *tecum* to secure the appearance of witnesses and the production of documents and  
19 to testify in connection herewith;  
20  
21 l. Prescribe guidelines for the implementation of its continuing professional  
22 education programs. CPE shall be mandatory for all fisheries professionals in  
23 coordination with the accredited national association of fisheries professionals;  
24  
25 m. Prepare, adopt and issue, in consultation with the academe, the syllabi or terms of  
26 specification of the subjects for the licensure examination and to amend the same;  
27 and  
28  
29 n. To discharge and perform such other duties and functions as may be necessary to  
30 carry out the objectives and purposes of this Act.  
31

32 Except matters which are ministerial in nature, all policies and functions of the Board  
33 embodied in resolutions as well as rules and regulations issued by the Board shall be subject  
34 to the review and approval of the Commission.  
35  
36

37 **SEC.10. Compensation and Allowance of the Chairman and Members of the**  
38 **Board.** – The Chairman and Members of the Board shall receive compensation and  
39 allowances comparable to the compensation and allowances received by the Chairmen and  
40 Members of other Professional Regulatory Boards.  
41  
42

43 **SEC. 11. Removal and Suspension of the Chairman and Members of the Board.** –  
44 The President may, upon recommendation of the Commission, remove any Member of the  
45 Board for any of the following causes:

- 46 a. Negligence;  
47  
48 b. Incompetence;  
49  
50 c. Immoral, dishonorable or unprofessional conduct;

1 d. Violation of, or abetting the violation of, the Resolution or Code of Ethics for  
2 Fisheries Professionals; and/or

3  
4 e. Conviction in a final judgment of a crime involving moral turpitude.  
5

6 The right of the respondent to due process and be assisted by counsel in an  
7 investigation shall be respected and upheld. The President may, also upon recommendation of  
8 the Commission, preventively suspend a Member under administrative investigation.  
9

10  
11 **SEC. 12. *Supervision of the Board, Custodian of its Records, Secretarial and***  
12 ***Support Services.*** – The Board shall be under the general supervision and administrative  
13 control of the Commission. All records of the Board including applications for examination,  
14 examination papers and results, minutes of deliberation, administrative cases and other  
15 investigations involving examinees and fisheries technologists shall be kept and subject to the  
16 disposition of the Commission.  
17

18 The Commission shall provide secretariat and support services to the Board for the  
19 efficient and effective implementation of the provisions of this Act.  
20

21  
22 **SEC. 13. *Annual Report.*** – The Board shall, at the close of each calendar year,  
23 submit an annual report to the Commission, of its proceedings and accomplishments during  
24 the year and make recommendations for the adoption of measures that will upgrade the  
25 conditions affecting the practice of the fisheries profession in the Philippines.  
26

27  
28 **ARTICLE III**  
29 **EXAMINATION AND REGISTRATION**  
30

31  
32 **SEC. 14. *Licensure Examination.*** – All applicants for registration for the practice of  
33 the fisheries profession shall be required to undergo and pass a written examination as  
34 provided in this Act except those who qualify for registration under Section 26 of this Act.  
35 The licensure examination for fisheries professionals shall be given by the Board at least once  
36 a year in such places and dates the Commission may designate in accordance with the  
37 provisions of Republic Act 8981.  
38

39  
40 **SEC. 15. *Scope of Examination.*** – The examination for fisheries professionals shall  
41 basically cover the following fields:

42 a. Aquatic Resources and Ecology  
43

44 b. Aquaculture  
45

46 c. Capture Fisheries  
47

48 d. Post-Harvest Fisheries



1 The board may also re-cluster, rearrange, modify add or exclude any of the foregoing  
2 subjects as the need arises and may recommend to CHED changes in said subjects to conform  
3 to modern and advanced technologies in the fisheries profession.  
4

5  
6 **SEC. 16. *Qualifications of Applicants for Examination.*** – Each applicant for  
7 examination shall establish to the satisfaction of the Board that:

- 8 a. He/she is citizen of the Philippines;  
9  
10 b. He/she is of good moral character and must not have been convicted of any crime  
11 involving moral turpitude; and  
12  
13 c. He/she is a graduate of at least a Bachelor's degree in the field of fisheries from a  
14 school, college or university established and recognized by the Government, or a  
15 recognized university abroad.  
16

17  
18 **SEC. 17. *Fraudulent Application.*** – The Board may suspend or revoke a certificate  
19 of registration and professional identification card already issued, if a registrant has been  
20 proved or found to have made misrepresentation/s in his application for examination.  
21

22  
23 **SEC. 18. *Rating in the Board Examination.*** – To pass the licensure examination for  
24 fisheries professionals, a candidate must obtain a weighted general average rating of seventy-  
25 five percent (75%) and with no grade lower than sixty percent (60%) in any given subjects.  
26 However, if an examinee obtained a general weighted average rating of seventy-five percent  
27 (75%) or higher but obtained a rating below sixty percent (60%) in any given subject/s,  
28 he/she shall be allowed to take the examination in the subject/s where a grade below sixty  
29 percent (60%) was obtained. This removal shall be availed of only once.  
30

31  
32 **SEC.19. *Report of Ratings.*** – The Board shall submit to the Commission the rating  
33 obtained by each examinee in the licensure examination within a period of ten (10) days after  
34 the examination in the last subject unless extended by the Commission for just and valid  
35 cause/s.  
36

37  
38 **SEC. 20. *Report on the Performance of Examinees in Licensure Examination.*** –  
39 The Board, through the Commission, may recommend to the Commission on Higher  
40 Education (CHED) the following:

- 41 a. The schools, colleges or universities whose successful examinees in three (3)  
42 consecutive licensure examination for Fisheries Technologists is less than eight  
43 percent (8%) of the total number of its candidates who took the licensure  
44 examinations shall be recommended for close monitoring of their fisheries  
45 program; and  
46  
47 b. The names of schools, colleges, or universities whose successful examinees in  
48 five (5) successive licensure examination for Fisheries Technologists is less than  
49 eight percent (8%) of the total number of its examinees in each of the licensure

1 examination taken shall be published in newspapers, and their fisheries course/  
2 program shall be recommended for closure.  
3

4  
5 **SEC. 21. Issuance of Certificate of Registration and Professional License.** – A  
6 certificate of registration shall be issued to examinees that passed the licensure examination  
7 for Fisheries Technologists, as well as to a person that qualified to register as fisheries  
8 professional without examination, subject to the payment of fees prescribed by the  
9 Commission. The Certificate of Registration, which indicates that the person named therein is  
10 entitled to practice as Fisheries Professional with all the benefits and privileges pertaining  
11 thereto, shall bear the signature of the Chairperson of the Commission and the Chairman and  
12 Members of the Board, and the seal of the Commission and the Board. *Provided*, That he/she  
13 shall be allowed to practice the profession without the need of securing another license from  
14 any government agency. The Certificate of Registration shall remain in full force and effect  
15 until revoked or suspended in accordance with this Act. A Professional Identification Card  
16 bearing the registration number, and date of issuance, shall be renewed every three (3) years  
17 and upon satisfying the requirements of the Board and Continuing Professional Education.  
18

19  
20 **SEC.22. Non-issuance of Certificate of Registration and Professional Identification**  
21 **Card.** – The Board shall not register and issue a Certificate of Registration to any successful  
22 examinee that has been convicted by a court of competent jurisdiction of any criminal offense  
23 involving moral turpitude, or has been found guilty of immoral or dishonorable conduct after  
24 investigation by the Board, or has been declared to be of unsound mind. The reason for the  
25 refusal shall be set forth in writing.  
26

27  
28 **SEC. 23. Revocation or Suspension of the Certificate of Registration, Professional**  
29 **Identification Card or Cancellation of Temporary/Special Permit.** – The Board may, after  
30 giving proper notice of hearing to the party concerned, revoke the Certificate of Registration  
31 and Professional Identification Card of a Fisheries Professional or suspend him/her from the  
32 practice of the profession or cancel his/her temporary/special permit for unprofessional or  
33 unethical conduct, malpractice, negligence, incompetence, or violation of any of the  
34 provisions of this Act, its Implementing Rules and Regulations (IRR), Code of  
35 Ethics/Professional Standards for Fisheries Professionals, and Code of Good Governance.  
36

37  
38 **SEC. 24. Reinstatement, Re-issuance, or Replacement of Certificate of Registration,**  
39 **Professional Identification Card and Temporary/Special Permit.** – The Board may, after  
40 two (2) years from the date of revocation of Certificate of Registration, reinstate any revoked  
41 Certificate of Registration and reissue a suspended Professional Identification Card.  
42

43  
44 **SEC. 25. Continuing Professional Development.** – All fisheries professionals shall  
45 abide by the requirements, rules, and regulation on continuing professional education to be  
46 promulgated by the PRC Regulatory Board, subject to the approval of the Commission, in  
47 coordination with the AIPO for fishery profession and the representative of duly accredited  
48 education institutions. For this purpose, the Board may create a CPD Council to implement  
49 the CPD program subject to the guidelines as may be issued by the Board.

1           **SEC. 26. Registration of Fisheries Professionals without Examination.** – Upon  
2 approval of the application and payment of the prescribed fees, certificate of registration and  
3 professional identification card shall be issued to the applicant for registration without  
4 examination who can prove to the satisfaction of the Board that items a, b, or c below has  
5 been met:

- 6           a. He/she has at least a bachelor's degree in any field of fisheries from a school,  
7 college or university established or recognized by the Government; *Provided,*  
8 That the applicant has passed any of the civil service examination in fisheries, or  
9 has been granted eligibility by the Civil Service Commission by virtue of PD 907,  
10 or passed the Career Service (Professional) examination given by the Civil  
11 Service Commission; *Provided further,* That the applicant has served the fisheries  
12 industry in public or private capacity for five (5) years before the effectivity of  
13 Republic Act 8550;  
14
- 15           b. He/she has a graduate degree(master or doctorate) in fisheries or closely related  
16 fields such as marine biology, oceanography/limnology, food  
17 science/technology/engineering, fish taxonomy, biotechnology as applied in  
18 fisheries, aquatic biology, fishing boat design/engineering, aquatic resource  
19 management, fish health, fish nutrition, or fish chemistry from a school, college or  
20 university, established or recognized by the Government: *Provided,* That the  
21 applicant has served the fisheries industry in public or private capacity for at least  
22 ten (10) years; *Provided further,* That the applicant has published five (5) research  
23 and highly technical papers in reputable journals, books and proceedings within  
24 the ten-year service in fisheries;  
25
- 26           c. He/she is a graduate of at least a bachelor's degree in fisheries from a school,  
27 college or university, established or recognized by the Government; *Provided,*  
28 That the applicant has served the fisheries industry (private sector) for a total of  
29 ten (10) years; *Provided further,* That he/she can show proof of achievements,  
30 awards, commendations, or promotions of deserving performance and has  
31 published at least two (2) technical papers in fisheries.  
32

33           The applicants are given one (1) year after the approval and publication of the  
34 Implementing Rules and Regulations of this Act to register as Fisheries Professionals without  
35 examination.  
36  
37

38           **SEC. 27. Roster of Fisheries Professionals.** – The Board, in coordination with the  
39 Accredited Professional Organization, shall prepare, update and maintain a Roster of  
40 Fisheries Professionals, their residence and office addresses, dates of registration or issuance  
41 of certificate, and other data which the Board may deem relevant.  
42

43           The roster shall be open to the public; copies of which shall be made available to any  
44 party as may be deemed necessary.  
45  
46

47           **SEC. 28. Issuance of Temporary/Special Permit.** – Upon application and payment of  
48 the required fee and subject to the approval of the Commission, the Board may issue  
49 temporary or special permits to fisheries professionals from foreign countries whose services

1 are urgently needed in the absence or inadequacy of local fisheries technologists for the  
2 purpose of promoting or enhancing the practice of the fisheries profession in the Philippines.  
3  
4

5 **SEC. 29. *Foreign Reciprocity.*** – No foreign fisheries professional shall be given a  
6 certificate of registration/professional license and professional identification card or be  
7 entitled to any of the privileges under this Act unless the country of which the foreign  
8 fisheries professional is a subject or citizen specifically permits Filipino fisheries  
9 professionals to practice within its territorial limits on the same basis as the subjects or  
10 citizens of said country or state.  
11  
12

13 **SEC. 30. *Seal and Use of Seal.*** – Every Fisheries Professional shall obtain a seal of  
14 such design as the Board shall adopt and approve which shall be impressed upon all  
15 documents, records, papers and/or instruments prepared by/or under the direct supervision of  
16 or issued by a registered Fisheries Professional only during the period of the validity of his  
17 professional identification card.  
18  
19

20 **SEC. 31. *Indication of Number, Certificate of Registration, Professional Tax***  
21 ***Receipt, and APO Membership Official Receipt.*** – Every registered Fisheries Professional  
22 shall be required to indicate the number of his certificate of registration, professional  
23 identification card, the date of issuance and expiration of said card including the number of  
24 his professional tax receipt, its date and place of issue, and APO Membership Official  
25 Receipt Number on any and all documents that he signs, uses or issues in connection with the  
26 practice of the Fisheries Profession.  
27  
28

29 **ARTICLE IV**  
30 **PRACTICE OF THE FISHERIES PROFESSION**  
31

32 **SEC. 32. *Oath.*** – All successful examinees and those qualified for registration  
33 without examination shall be required to take an oath of profession before any member of the  
34 Board or any officer of the Commission authorized by it, or any person authorized by law to  
35 administer oaths prior to entering into the practice of the fisheries profession.  
36  
37

38 **SEC. 33. *Acts Constituting the Practice of the Fisheries Profession.*** – Any single act  
39 or transaction embraced within the provision of Section 5 hereof shall constitute an act of  
40 engaging in the practice of the fisheries profession.  
41  
42

43 **SEC. 34. *Prohibition Against the Unauthorized Practice of the Fisheries***  
44 ***Profession.*** – No person shall practice the fisheries profession in the Philippines or offer  
45 himself/herself as Fisheries Professional, or use the title, word, letter, figure or any sign  
46 tending to convey the impression that one is a Fisheries Professional, or advertise or indicate  
47 in any manner whatsoever that one is qualified to practice the profession, unless he/she has  
48 satisfactorily passed the Board licensure examination for Fisheries Professionals, or  
49 registered as a Fisheries Professional without examination, except as otherwise provided in  
50 this Act, and is a holder of a valid Certificate of Registration and a Professional Identification

1 Card or a valid temporary/special permit duly issued to him/her by the Board and the  
2 Commission.  
3  
4

5 **SEC. 35. *Prohibition Against Corporate Practice.*** – The practice of fisheries  
6 professionals is a professional service, admission to which shall be determined upon basis of  
7 individual and personal qualification. No firm, company, or association may be registered or  
8 licensed as such for the practice of the fisheries profession.  
9

10  
11 **SEC. 36. *Prohibition Against Hiring Unlicensed Fisheries Professionals.*** –  
12 Government agencies, educational institutions, private corporations/companies, and  
13 entrepreneurs in fisheries are prohibited from hiring unlicensed Fisheries Professionals whose  
14 work is defined in Section 5 of this Act.  
15  
16

17 **SEC. 37. *Integration of Fishery Profession.*** – The fishery profession shall be  
18 integrated into one (1) national professional organization of fisheries professionals which  
19 shall be duly registered with the Securities and Exchange Commission (SEC). The Board,  
20 subject to approval by the Commission, shall accredit the said organization as the one and  
21 only Accredited and Integrated Professional Organization (AIPO) of registered fisheries  
22 professionals. All fisheries professionals whose names appear in the Registry Book of  
23 Fishery Profession shall ipso facto or automatically become members thereof and shall  
24 receive all the benefits and privileges appurtenant thereto upon payment of AIPO  
25 membership fees and dues.  
26

27 Membership in the Accredited Integrated Professional Organization (AIPO) shall not  
28 be a bar to membership in other organizations of fishery profession.  
29  
30

31 **SEC. 38. *Code of Ethics and Professional Standards.*** – The Board shall adopt and  
32 promulgate the Code of Ethics and the Code of Professional Standards for Fisheries  
33 Professionals which shall be issued by the Accredited Professional Organization of Fisheries  
34 Professionals.  
35  
36

37 **SEC. 39. *Vested Rights: Automatic Registration of Fisheries Professionals.*** – All  
38 Fisheries Technologists who are registered and licensed under Resolution 01(Series of 2002)  
39 of the Board of Fisheries, PRC, entitled “Rules and Regulations Implementing PRC  
40 Resolution No. 2000-664, As Amended” (Creation of the Board of Fisheries as mandated by  
41 Section 115 of R.A. 8550, otherwise known as the Fisheries Code of 1998”) at the time this  
42 Act takes effect shall automatically be registered as Fisheries Professionals.  
43  
44

45 **ARTICLE V**  
46 **PENAL AND FINAL PROVISIONS**  
47

48 **SEC. 40. *Penal Provisions.*** – Any violation of this Act, including the violations of  
49 the Implementing Rules and Regulations thereof, shall be meted the penalty of a fine of not  
50 less than Fifty Thousand Pesos (Php 50,000.00) or more than Five Hundred Thousand Pesos

1 (Php 500,000.00), or imprisonment of not less than six (6) months, or both upon the  
2 discretion of the court.  
3  
4

5 **SEC. 41. Appropriation.** – There shall be an initial appropriation of Twenty Million  
6 Pesos (Php 20,000,000.00) to be disbursed for the operation of the Board of Fisheries which  
7 shall include personal services, maintenance and other operating expenses and capital outlay.  
8 In succeeding years the Chairperson of the Professional Regulation Commission shall  
9 immediately include in the Commission's programs the implementation of this Act, the  
10 funding of which shall be included in the Annual General Appropriations Act and thereafter.  
11  
12

13 **SEC. 42. Transitory Provision.** – The existing Board of Fisheries shall continue to  
14 function in the interim without another appointment until such time that the new Board shall  
15 have been constituted pursuant to this Act.  
16  
17

18 **SEC. 43. Implementing Rules and Regulations.** – The Board shall, subject to the  
19 approval of the Commission, adopt, promulgate and issue the Implementing Rules and  
20 Regulations, in coordination with the accredited professional organization and other fisheries  
21 institutions, to implement or carry out the provisions of this Act.  
22  
23

24 **SEC. 44. Separability Clause.** – If any clause, sentence, paragraph, or part of this Act  
25 shall be declared unconstitutional or invalid, such judgment shall not affect, invalidate or  
26 impair any other part of this Act.  
27  
28

29 **SEC. 45. Repealing Clause.** – Section 115 of R.A. 8550 and Section 75 of R.A. 8435  
30 and PRC Resolution No. 2000-664, Series of 2000 are hereby repealed. All other laws,  
31 decrees, executive orders, and other administrative issuances and parts thereof which are  
32 inconsistent with the provisions of this Act are hereby modified, superseded or repealed  
33 accordingly.  
34  
35

36 **SEC. 46. Effectivity.** – This Act shall take effect fifteen (15) days following its full  
37 and complete publication in the Official Gazette or in any major newspaper of general  
38 circulation in the Philippines.
