#### **PARLIAMENTARY INQUIRY OF SENATOR DE LIMA**

Senator De Lima stated that earlier the Chair referred two vetoed bills, namely, Senate Bill No. 2419, to the Committee on Justice and Human Rights, and House Bill No. 6080, to the Committee on Energy and Cooperative, and she assumed that their referral to the committees was for purposes of study and recommendations to plenary whether or not these vetoed bills should be reconsidered. She then inquired if there is a prescribed period for the concerned committees within which to study and recommend to plenary whether or not these vetoed bills be reconsidered because there is nothing in the *Rules of the Senate*, particularly Rule XLIX in relation to Article VI, Section 27 of the Constitution, that provides a time frame within which to consider a vetoed bill.

**REPLY OF THE CHAIR**

Replying to the parliamentary inquiry of Senator De Lima regarding the mandatory time frame for the committee concerned within which to come up with a recommendation, Senate President Pimentel referred to Section 134, Rule XLIX of the *Rules of the Senate* which governs the procedure on vetoed bills, and he opined that there is nothing in the *Rules* that provides for mandatory time frame, but if the measure is deemed urgent, he cited Section 31 of the Rules which urges all committees to come up with a report on the bills and resolutions referred to it within 30 session days. He clarified that his reply was a mere opinion and was therefore non-binding.

**MANIFESTATION OF SENATOR DRILON**

Senator Drilon noted that Senator De Lima was specifically asking if there is any period given to the Senate within which to override a veto, and he opined that there is no period. He stated that if ever an override is going to be done, it can be done during the life of the Congress which received the veto message; if the message was received in the 17<sup>th</sup> Congress, theoretically it is within the life of this Congress that the override can be done.

Senator De Lima subscribed to the view of Senator Drilon because she also did not see any provision in the Rules as regards the period. She agreed that any action should be undertaken during the life of the Congress so as to avoid unduly restricting the prerogatives of the Body. She also agreed with the explanation of President Duterte, which was contained in his veto message, that Senate Bill No. 2419, which seeks to ban the re-appointment of a regular member of the Judicial and Bar Council (JBC), if it was passed into law, would encroach on the plenary power of appointment of the President.

Senator Drilon also proposed that Senate Bill No. 81, the subject of which is to allow the formation of one-person corporations, which is basically included in Senate Bill No. 231 (An Act Revising the Corporation Code of the Philippines), be referred to the Committee on Constitutional Amendments and Revision of Codes as the primary committee, and to the Committee on Trade, Commerce and Entrepreneurship as the secondary committee.

Senate President Pimentel noted, however, that Senate Bill No. 81 concerns an amendment to only a specific section of the Corporation Code which is not considered a revision of the Code, thereby not falling under the jurisdiction of the Committee on Constitutional Amendments and Revision of Codes.

Senator Drilon explained that he was proposing to amend the original referral of Senate Bill No. 81 only for purposes of achieving symmetry and uniformity to avoid a similar situation in the future where there could be a possibility of two committees treating the same bill in a different manner.

Asked to comment on the proposal, Senator Sotto interposed no objection thereto. Senate President Pimentel stated that the proposed change of referral shall be considered as an exception to the general rule.

Acting on the motion of Senator Drilon, there being no objection, Senate President Pimentel referred Senate Bill No. 81 instead to the Committee on Constitutional Amendments and Revision of Codes as the primary committee, and to the Committee on Trade, Commerce and Entrepreneurship as the secondary committee.

RESOLUTION RECOGNIZING AND COMMENDING TREAT CONRAD HUEY FOR HIS INVALUABLE CONTRIBUTION TO PHILIPPINE SPORTS AS THE FIRST FILIPINO WHO QUALIFIED FOR THE SEMIFINAL ROUND OF A GRAND SLAM TENNIS TOURNAMENT.

Secretary Barbo read only the title of the resolution without prejudice to the insertion of its full text into the record.

*Following is the full text of the resolution, to wit:*

WHEREAS, Filipino-American, Treat Conrad Huey, together with his Belarusian partner, Max Mirnyi, defeated Austrian Oliver Marach and French Fabrice Martin with the score of 6-3, 6-2, 7-6(3) at the quarterfinals of The Championships, Wimbledon held at the All England Lawn Tennis Croquet Club in London last July 7, 2016 and has since advanced to the semifinal round of the tournament;

WHEREAS, The Championships, Wimbledon, or most commonly referred to as Wimbledon, is the oldest and among the most prestigious tennis tournaments in the world. It is one of the only four Grand Slam tennis tournament, together with the Australian Open, French Open and the US Open. These Grand Slam annual tournaments are the four most important events in the tennis world;

WHEREAS, ranked 24<sup>th</sup> in the world, Huey is the first Filipino to make the semifinals at Wimbledon. He had previously reached the men’s double quarterfinals in Australian Open in 2014 and 2016, and in the US Open in 2013.

WHEREAS, Huey has specialized in doubles and has reached fifteen finals in the ATP World Tour. He has won various titles including the 2012 Citi Open, 2013 Swiss Indoors, 2014 Aegon with Dominic Inglot, 2015 Estoril Open with Scott

Lipsky, 2015 St. Petersburg Open, and 2015 Malaysian Open, Kuala Lumpur with Henri Kontinen. He has also participated in the International Premier Tennis League (IPTL);

WHEREAS, Huey has been representing the country in various international tennis competitions. He turned professional in 2008 and started representing the Philippines in the Davis Cup and in the Southeast Asian Games in 2009. He has shown the talent and skill of a Filipino tennis athlete in an international premier tennis tournament. He has continued to promote the Philippines and its people through his outstanding performances in tennis;

WHEREAS, Huey’s success especially his performance at the 2016 Wimbledon has given a much-needed boost to Philippine tennis. His breakthrough was hailed as a “heroic performance” continuing to raise the bar for Filipino tennis players;

NOW, THEREFORE, BE IT RESOLVED, that the Senate of the Philippines recognize and commend Treat Conrad Huey for his invaluable contribution to Philippine sports as the first Filipino who qualified for the semifinal round of a Grand Slam tennis tournament.

WHEREAS, the R. William Jones Cup, also known as the Jones Cup, is an international basketball tournament held annually since 1977 in Taipei, Taiwan. It was named in honor of basketball promoter Renato William Jones, who was one of the founders of the International Basketball Federation (FIBA);

WHEREAS, the 2016 Jones Cup was participated by ten (10) teams from nine (9) countries namely: Canada, Egypt, Iran, India, Japan, Korea, Taiwan, United States of America and the Philippines;

WHEREAS, the Philippines was represented by the Mighty Sports Apparel Team, called Mighty Sports Philippines, comprising of 14 players, led by its team captain Edrick Ferrer and Bo Perasol as their head coach;

WHEREAS, the Philippine squad finished the tournament with an 8-0 record and secured the title even before its final outing;

WHEREAS, since the Jones Cup started, the Philippines got four (4) championships – in 1981 by Northern Cement, 1985 by San Miguel Beer, 2012 by the Philippine Centennial team and 2016 by the Mighty Sports Philippines;

WHEREAS, by reason of the foregoing championships, the Philippines placed second behind the United States in the all-time Jones Cup medal ladder with five (5) gold, one (1) silver and three (3) bronze medals reaped;

NOW, THEREFORE, BE IT RESOLVED, as it is hereby resolved, to commend and congratulate the Mighty Sports Philippines Team for topping the 38<sup>th</sup> Jones Cup in an eight-game sweep held from July 23-31, 2016 in Taipei, Taiwan bringing another recognition to the Philippines in the field of basketball.

#### **SPONSORSHIP REMARKS OF SENATOR SOTTO**

Senator Sotto said that it was very rare for a team representing the country to win with an 8-0 winning streak especially since the countries which competed in the Jones Cup included Canada, Egypt, Iran, India, Japan, Korea, Taiwan, and the United States. He said that the Philippines has won the Cup four times – in 1981 by Northern Cement, 1985 by

San Miguel Beer, 2012 by the Philippine Centennial team and 2016 by the Mighty Sports Philippines.



WHEREAS, twelve (12) Filipino athletes – namely, swimmers Jasmine Alkhaldi and Jessie Lacuna; table tennis paddler Ian Lariba; golfer Miguel Luis Tabuena; long jumper Maristella Sunang; hurdler Eric Cray; marathon runner Mary Joy Tabal; weightlifters Hidilyn Diaz and Nestor Colonia; boxers Rogen Ladon and Charley Suarez; and taekwondo jin Kristie Alora shall represent the Philippines at the 2016 Summer Olympics in Rio de Janeiro from August 5 to 21, 2016;

WHEREAS, this delegation's participation will be the 21<sup>st</sup> instance the Philippines participates in the Summer Olympics. The country first sent athletes during the 1924 Olympics in Paris, France wherein the Philippines was the first Southeast Asian country to compete and win a medal;

WHEREAS, the Summer Olympics is a globally recognized multi-sport event, organized by the International Olympic Committee and held every four years;

WHEREAS, swimmers Jasmine Alkhaldi and Jessie Lacuna have already represented the country in various sporting events. Alkhaldi holds the Philippine women's record in the 200-, 100- and 50-meter freestyle and the 50- and 100-meter butterfly events, while Lacuna has a total fifty-one (51) gold medals with thirty-five (35) national and sixteen (16) international titles, and registered a personal best of one minute, fifty point seventy three seconds (1:50.73) during the 2015 Southeast Asian Games in Singapore;

WHEREAS, table tennis paddler Ian Lariba is the country's flag bearer for the 2016 Rio Olympics ceremony. Lariba represented the country in various international table tennis championships including the 2014 World Table Tennis Team Championships in Japan where she led the Philippines to a first-place victory;

WHEREAS, golfer Miguel Luis Tabuena has been playing the Asian Tour since 2011. Tabuena won the 2015 Philippine Open and was named by the Philippine Sportswriters Association as one of the "Sportsmen of the Year" for 2016;

WHEREAS, long jumpers Maristella Sunang, Eric Cray and Mary Joy Tabal shall be competing in their respective categories. Ranked 28<sup>th</sup> in the world, Sunang won gold in July 2016 at the Kazakhstan Open, setting a new Philippine record of 6.72 meters. Sunang participated in the

2008 Beijing and 2012 London Olympics. Cray set a new national record in the 400-meter hurdles even while winning gold at the 2015 Southeast Asian Games, setting a time of forty-nine point forty (49.40) seconds. Meanwhile, Tabal won silver in the 2015 Southeast Asian Games and represented the Philippines in the 2016 Boston Marathon;

WHEREAS, weightlifters Hidilyn Diaz and Nestor Colonia's participation shall be the first time the Philippines will send a pair of lifters since the 1988 Seoul Olympics. In November 2015, during the International Weightlifting Federation (IWF) World Weightlifting Championship, Colonia won a bronze medal in the clean-and-jerk 56 kg. categories division while Diaz won three bronze medals in the snatch, clean-and-jerk, and total categories in the women's 53 kg division, becoming the first Filipina to win a medal in the competition. The Rio Olympics will be the third consecutive time Diaz participates in the games, after 2008 Beijing and 2012 London;

WHEREAS, boxers Rogen Ladon and Charly Suarez will compete in their respective categories. Ladon has won various international tournaments such as the Asia Amateur Boxing Championships and Southeast Asian Games. Suarez won via technical knockout (TKO) in the semifinals of the Asian-Oceanic Olympic Qualifiers in China;

WHEREAS, taekwondo jin Kristie Alora is the first Filipino jin to make it to the Olympics since Marie Antoniette Rivero and Tshomlee Go represented the country in the 2008 Beijing Olympics;

WHEREAS, the Philippines has not won an Olympic medal since Mansueto "Onyok" Velasco won a silver medal in the light flyweight boxing competition in the 1996 Olympics in Atlanta, United States. The Philippines has won a total of nine (9) Olympic medals so far;

**NOW, THEREFORE, BE IT RESOLVED,** that the Senate of the Philippines recognizes, commends and extends its well-wishes to the twelve athletes – swimmers Jasmine Alkhaldi and Jessie Lacuna; table tennis paddler Ian Lariba; golfer Miguel Luis Tabuena; long jumpers Maristella Sunang, Eric Cray and Mary Joy Tabal; weightlifters Hidilyn Diaz and Nestor Colonia; boxers Rogen Ladon and Charly Suarez; and taekwondo jin Kristie Alora at the 2016 Summer Olympic Games in Rio de Janeiro, Brazil from August 5 to 21, 2016.

**SPONSORSHIP SPEECH  
OF SENATOR ANGARA**

In sponsoring Proposed Senate Resolution No. 75, Senator Angara delivered the following speech:

Our people have always been sport lovers whether it is basketball, boxing, volleyball or football. There is probably a Filipino out there who loves that sport. This is no less evident during the times the whole country used to stop and drop everything for the boxing bouts of our *Pambansang Kamao* who is now a proud colleague of ours, Sen. Manny Pacquiao.

We anticipate the country will extend the same fervor, the same support to the 12 Filipino athletes who are on their way to the Rio Olympics, namely, swimmers Jasmine Alkhaldi and Jessie Lacuna; table tennis paddler Ian Lariba; golfer Miguel Luis Tabuena; long jumper Maristella Sunan; hurdler Eric Cray; marathon runner Mary Joy Tabal; weightlifters Hidilyn Diaz and Nestor Colonia; boxers Rogen Ladon and Charly Suarez; and taekwondo jin Kristie Alora.

These 12 shall represent the Philippines at the 2016 Summer Olympics in Rio de Janeiro from August 5 to 21, 2016. And that is why, with the resolution we are sponsoring, we wish to recognize and commend them for getting into the Olympics, for the road they have faced was nothing short of tough.

They are nothing short of world-class as well. Jasmine Alkhaldi holds the Philippine women’s record in the 200-, 100-, and 50-meter freestyle and the 50-, and 100-meter butterfly events, while Jessie Lacuna has a total 51 gold medals with 35 national and 16 international titles, and registered a personal best of one minute, 50.73 seconds (1:50:73) during the 2015 Southeast Asian Games in Singapore.

Table tennis paddler Ian Lariba who will be the country’s flag bearer for the 2016 Rio Olympics opening ceremony represented the country in various international table tennis competitions including the 2014 World Table Tennis Team Championships in Japan where she led the Philippines to a first-place victory.

Ranked 28th in the world, Maristella Sunang won gold in July 2016 at the Kazakhstan Open, setting a new Philippine record of 6.72 meters. Sunang participated in the 2008 Beijing and 2012 London Olympics. Eric Cray, on the other hand, set a new national record in the 400-meter hurdles event while winning gold at the 2015 Southeast Asian Games, setting a time of 49.40 seconds. Meanwhile, Mary Joy Tabal won

silver in the 2015 Southeast Asian Games and represented the Philippines in the 2016 Boston Marathon.

Despite their achievements, we continue to overlook the significance of our athletes in nation building, providing them very little support or incentive to succeed. Of course, in the 16th Congress, we raised the incentives our national athletes receive. But we can definitely do more—especially in providing full institutional support and training for them.

I am happy to note that during President Duterte’s send-off for the Philippine Team to the 2016 Rio Olympics, he expressed his support through increasing the allowance of the athletes from \$1000 to \$3000 and of the officials from \$3000 to \$5000.

The Senate has been filing resolutions congratulating various athletes in different international competitions. Perhaps in the future, we can do more than this. We need systemic reform, including grass roots development, higher budgets, and long-term planning. *Para hindi lang puro* “congratulations.” We should offer our athletes more.

I congratulate our *Pambansang Kamao*, Sen. Manny Pacquiao, for being the incoming chairman of the Senate Committee on Sports.
