Senator Sotto acknowledged the presence in the gallery of the guests of Senator Villar, Mayor Antonio "Tony" Carolino and his wife, former Mayor Cindy Carolino of Santa Maria, Laguna.

Senate President Pimentel welcomed the guests to the Senate.

COMMITTEE VICE CHAIRPERSONS

On behalf of Senator Villar, Senator Sotto manifested for the record the designation of Senators Legarda and Ejercito as vice chairpersons of the Committee on Environment and Natural Resources.

MOTION OF SENATOR SOTTO

Acting on the request of Senator Recto, Senator Sotto moved to amend the primary and secondary referral of Senate Bill No. 264 (instituting reforms to further protect and develop micro, small and medium enterprises) from the Committee on Government Corporations and Public Enterprises to the Committee on Banks, Financial Institutions and Currencies as the primary committee, with the Committee on Government Corporations and Public Enterprises as secondary committee.

He said that he found merit on the request of Senator Recto because after going over the provisions of the bill, it appeared that the measure relates more to matters that would affect the functions and operations of the Development Bank of the Philippines (DBP) as a bank or financial institution.

INQUIRY OF SENATOR GORDON

At this point, Senator Gordon asked what the bill was, the referral of which is being sought to be changed.

Senator Sotto replied that the measure is Senate Bill No. 264.

SUSPENSION OF SESSION

Upon motion of Senator Sotto, the session was suspended.

It was 3:55 p.m.

RESUMPTION OF SESSION

At 3:56 p.m., the session was resumed.

Upon resumption, Senator Sotto informed the Body that after consultation between the chair of the Committee on Banks, Financial Institutions and Currencies and the chair of the Committee on Government Corporations and Public Enterprises, both agreed that Senate Bill No. 264 should be primarily referred to the Committee on Banks, Financial Institutions and Currencies.

Senator Gordon said that he was not objecting to the change of referral of bills. However, he requested that the chairs of the respective committees to which the bills were previously referred

ms mt

be notified in advance before any changes in referral are made on the floor.

He said that while there were no problems in the particular change in the referral, there could be problems in the future and, for that reason, reiterated his request that from hereon, the affected committee chairs be given advance notice so that they would have enough time to see whether the change of referral was proper. He explained that he has no intention of disrespecting anyone and that he was making the comment in the interest of good order and friendship and a relationship which he would not want to be threatened by surprises.

Senator Sotto said that Senator Gordon's request was well taken and he instructed the Secretariat to ensure that the concerned committee chairs are properly notified prior to making any changes in the referral of bills.

CHANGE OF REFERRAL

Acting on the previous motion of Senator Sotto, there being no objection, the Chair referred Senate

Bill No. 264 primarily to the Committee on Banks, Financial Institutions and Currencies, and secondarily to the Committee on Government Corporations and Public Enterprises.
