AN ACT DIVIDING BARANGAY NORTH BAY BOULEVARD SOUTH  
IN THE CITY OF NAVOTAS INTO THREE (3) DISTINCT AND  
INDEPENDENT BARANGAYS TO BE KNOWN AS BARANGAY  
NBBS PROPER, BARANGAY NBBS KAUNLARAN AND  
BARANGAY NBBS DAGAT-DAGATAN

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

1           SECTION 1. *Division of North Bay Boulevard South.* – Barangay  
2 North Bay Boulevard South in the City of Navotas is hereby divided into three  
3 (3) distinct and independent barangays to be known as Barangay NBBS  
4 Proper, Barangay NBBS Kaunlaran and Barangay NBBS Dagat-Dagatan.

5           SEC. 2. *Territorial Boundaries.* – The territorial boundaries of each  
6 barangay created in the immediately preceding section shall be as follows:

7           (1) Barangay NBBS Proper

8           “Bounded on the Northwest (NW) by centreline of Lapu-Lapu Avenue;

9           On the Northeast (NE) by centreline of North Bay Boulevard;

10          On the Southeast (SE) by centreline of Estero de Muralla; and

11          On the Southwest (SW) by Manila Bay and dried-up portion of Manila

12 Bay Two 003901-000959-D (PEA) Cad – 13 Manila Cadastre;

13          Containing an area of 589,344.87 square meters, more or less.”

1 (2) Barangay NBBS Kaunlaran

2 "Bounded on the Northwest (NW) by centreline of Lapu-Lapu Avenue;

3 On the Northeast (NE) by centrelines of Navotas River (Dagat-Dagatan  
4 River) and Estero de Muralla;

5 On the Southeast (SE) by centreline of Estero de Muralla; and

6 On the Southwest (SW) by centreline of North Bay Boulevard;

7 Containing an area of 614,932.53 square meters, more or less."

8 (3) Barangay NBBS Dagat-Dagatan

9 "Bounded on the Northwest (NW) by centreline of Malabon River/Cut  
10 Off Channel;

11 On the Northeast (NE) by centrelines of Martiniko Street and Dalagang  
12 Bukid Street;

13 On the Southeast (SE) by centerlines of Lapu-Lapu Avenue and C3  
14 Road; and

15 On the Southwest (SW) by centreline of Navotas River (Dagat-Dagatan  
16 River);

17 Containing an area of 396,345.04 square meters, more or less."

18 SEC. 3. *Conduct and Supervision of Plebiscite.* – The Commission on  
19 Elections (COMELEC) shall conduct and supervise the plebiscite to be held in  
20 Barangay North Bay Boulevard South in the City of Navotas within thirty (30)  
21 days from the effectivity of this Act.

22 The expenses for the plebiscite shall be borne by the City of Navotas.

23 SEC. 4. *Special Election of Barangay Officials.* – The first set of  
24 officials of the barangays created under Section 1 hereof shall be elected  
25 within ninety (90) days from approval by majority of the votes cast in a  
26 plebiscite held for the purpose.

27 The COMELEC shall conduct and supervise the special elections to be  
28 held in Barangay NBBS Proper, Barangay NBBS Kaunlaran and Barangay

1 NBBS Dagat-Dagatan in the City of Navotas within sixty (60) days after the  
2 ratification of this Act in a plebiscite.

3 The expenses for such special elections shall be borne by the City of  
4 Navotas.

5 The incumbent barangay officials of Barangay North Bay Boulevard  
6 South shall continue to hold office and administer barangays NBBS Proper,  
7 NBBS Kaunlaran and NBBS Dagat-Dagatan until such time that the officials  
8 of the newly created barangays have been duly elected and qualified.

9 *SEC. 5. Public Infrastructures and Facilities.* – All existing public  
10 infrastructures and facilities for public use existing therein at the time of the  
11 approval of this Act are hereby transferred without cost or compensation to  
12 and shall be administered by the new barangays.

13 *SEC. 6. Internal Revenue Allotment Shares.* – All barangays herein  
14 created shall be entitled to Internal Revenue Allotment (IRA) shares pursuant  
15 to Section 285 of Republic Act No. 7160, as amended, otherwise known as the  
16 Local Government Code of 1991.

17 *SEC. 7. Effectivity.* – This Act shall take effect fifteen (15) days after  
18 its complete publication in at least two (2) newspapers of general circulation in  
19 the Philippines.
