

AN ACT NAMING THE DIVERSION ROAD IN SORSOGON CITY,  
PROVINCE OF SORSOGON AS SALVADOR H. ESCUDERO III  
DIVERSION ROAD

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

1           SECTION 1. The diversion road in Sorsogon City, Province of  
2 Sorsogon shall hereinafter be known as Salvador H. Escudero III Diversion  
3 Road.

4           SEC. 2. The Department of Public Works and Highways shall issue the  
5 necessary rules, orders and circulars to implement the provision of this Act.

6           SEC. 3. This Act shall take effect fifteen (15) days after its publication  
7 in the *Official Gazette*.
