



BARANGAY BENGCAJ, CITY OF LAOAG, TO BARANGAY
BUYON, MUNICIPALITY OF BACARRA, PROVINCE OF ILOCOS
NORTE, AS THE RODOLFO G. FARIÑAS, JR. BY-PASS ROAD

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. The by-pass road stretching from Barangay Bengcag, City
2 of Laoag, to Barangay Buyon, Municipality of Bacarra, Province of Ilocos
3 Norte, is hereby named as the Rodolfo G. Fariñas, Jr. By-Pass Road.

4 SEC. 2. The Department of Public Works and Highways (DPWH) shall
5 include in their annual budget the funds necessary for the implementation of
6 this Act including installation and maintenance of signages thereat.

7 SEC. 3. This Act shall take effect fifteen (15) days after its publication
8 in the *Official Gazette* or in a newspaper of general circulation.
