AN ACT NAMING THE BY-PASS ROAD STRETCHING FROM BARANGAY BENGCAG, CITY OF LAOAG, TO BARANGAY BUYON, MUNICIPALITY OF BACARRA, PROVINCE OF ILOCOS NORTE, AS THE RODOLFO G. FARINAS, JR. BY-PASS ROAD

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

- SECTION 1. The by-pass road stretching from Barangay Bengcag, City of Laoag, to Barangay Buyon, Municipality of Bacarra, Province of Ilocos Norte, is hereby named as the Rodolfo G. Fariñas, Jr. By-Pass Road.

 SEC. 2. The Department of Public Works and Highways (DPWH) shall include in their annual budget the funds processary for the implementation of
- include in their annual budget the funds necessary for the implementation of this Act including installation and maintenance of signages thereat.

 SEC. 3. This Act shall take effect fifteen (15) days after its publication
- 8 in the Official Gazette or in a newspaper of general circulation.
