

#### AN ACT

### NAMING THE INTERSECTION OF JOSE ABAD SANTOS AVENUE (GAPAN-SAN FERNANDO-OLONGAPO ROAD) AND THE **GUAGUA-FLORIDABLANCA PROVINCIAL ROAD LOCATED AT THE** BORDER OF BARANGAY SAN ANTONIO AND BARANGAY JOSE ABAD SANTOS, BOTH IN THE MUNICIPALITY OF GUAGUA, PROVINCE OF PAMPANGA AS THE "WILLIAM GOLANGCO JUNCTION"

#### **EXPLANATORY NOTE**

In the Municipality of Guagua, Province of Pampanga, an intersection at the borders of Barangay San Antonio and Barangay Jose Abad Santos is located.

For the past four decades, the junction has been called "Golangco", after Engr. William C. Golangco, a pioneer in the Philippine construction industry, established his construction company depot in Barangay San Jose Santos. The William Golangco Construction Corporation made significant contributions to the economic growth and development of Barangay San Antonio and Barangay Jose Abad Santos.

This bill seeks to name the intersection of Jose Abad Santos Avenue (Gapan-San Fernando-Olongapo Road) and the Guagua-Floridablanca Provincial Road as the "William Golangco Junction". This will make identification to the site easy and make affinity to the intersection more recognized

In view of the foregoing, the immediate passage of this bill is earnestly sought.

.0	Be it enacted by the Senate and House of Representatives of the Philippines in Congress

3	SECTION 1. The intersection of Jose Abad Santos Avenue (formerly the Gapan-San
4	Fernando-Olongapo Road) and the Guagua-Floridablanca Provincial Road located at the
5	border of Barangay San Antonio and Barangay Jose Abad Santos, both in the
6	Municipality of Guagua, Province of Pampanga is hereby named the "William Golangco
7	Junction".

.9	SECTION 2. The Department of Public Works and Highways shall issue the necessary
20	rules, orders and circulars to implement the provision of this Act.

22	SECTION 3. This Act shall take effect fifteen (15) days after its publication in the
23	Official Gazette or in a newspaper of general circulation
