

AN ACT CREATING A BARANGAY TO BE KNOWN AS BARANGAY
CUMAWAS IN THE CITY OF BISLIG, PROVINCE OF SURIGAO
DEL SUR

*Be it enacted by the Senate and House of Representatives of the Philippines
in Congress assembled:*

1 SECTION 1. *Creation of Barangay Cumawas.* – There is hereby
2 created a barangay to be known as Barangay Cumawas in the City of Bislig,
3 Province of Surigao del Sur.

4 The territorial boundaries of Barangay Cumawas are described as
5 follows:

1 SEC. 2. *Conduct and Supervision of Plebiscite.* – The plebiscite
2 conducted and supervised by the Commission on Elections (COMELEC)
3 pursuant to Provincial Ordinance No. 103-94 of the Sangguniang
4 Panlalawigan of the Province of Surigao del Sur, which ratified the creation of
5 Barangay Cumawas as proclaimed by the Plebiscite Board of Canvassers on
6 November 13, 1996, shall serve as a substantial compliance with the
7 plebiscite requirement under Section 10 of Republic Act No. 7160, as
8 amended, otherwise known as the “Local Government Code of 1991”.

9 SEC. 3. *Incumbent Barangay Officials.* – The incumbent barangay
10 officials of Barangay Cumawas, City of Bislig, Province of Surigao del Sur
11 shall continue to hold office until such time that their successors have been
12 duly elected and qualified.

13 SEC. 4. *Public Infrastructure and Facilities.* – All public
14 infrastructure and facilities for public use existing therein at the time of the
15 approval of this Act are hereby transferred without cost or compensation to
16 and shall be administered by the new barangay.

17 SEC. 5. *Internal Revenue Allotment Shares.* – Barangay Cumawas
18 shall be entitled to Internal Revenue Allotment shares pursuant to Section 285
19 of Republic Act No. 7160, as amended, otherwise known as the “Local
20 Government Code of 1991”.

21 SEC. 6. *Effectivity.* – This Act shall take effect fifteen (15) days after
22 its publication in the *Official Gazette* or in any newspaper of general
23 circulation.
