AN ACT DIVIDING BARANGAY MAGUGPO IN THE CITY OF TAGUM, PROVINCE OF DAVAO DEL NORTE INTO FIVE (5) DISTINCT AND INDEPENDENT BARANGAYS TO BE KNOWN AS BARANGAY MAGUGPO POBLACION, BARANGAY MAGUGPO EAST, BARANGAY MAGUGPO WEST, BARANGAY MAGUGPO NORTH AND BARANGAY MAGUGPO SOUTH

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. *Division of Barangay Magugpo.* – Barangay Magugpo in
2 the City of Tagum, Province of Davao del Norte is hereby divided into five (5)
3 distinct and independent barangays to be known as (1) Barangay Magugpo
4 Poblacion, (2) Barangay Magugpo East, (3) Barangay Magugpo West,
5 (4) Barangay Magugpo North and (5) Barangay Magugpo South.

6 SEC. 2. *Territorial Boundaries.* – The territorial boundaries of each
7 barangay created in the immediately preceding section shall be as follows:

8 (1) Barangay Magugpo Poblacion
9 “Beginning at a point being the road junction of Sobrecarey Street,
10 Pioneer Avenue, Pagsabangan Road and Dalisay Road, hence; South 53 East,
11 traversing centerline of roadway up to the junction of Pioneer Avenue and
12 Seminary Drive, North 54 East, following Seminary Drive up to crossing
13 Domingo Subdivision Road; South 85 East; passing Domingo Subdivision

1 Road up to its junction with the National Highway, South 40 West, following
2 National Highway to Magugpo Crossing, South 53 30 East, to Crossing
3 Gamao Road, North 87 West, to junction National Highway and
4 Lapu-Lapu Street, South 40 West, passing National Highway up to crossing
5 Sobrecarey Street and North 2 30 East, passing Sobrecarey Street, to the point
6 of beginning. Bearings true.

7 "Bounded on the North along Pioneer Avenue, Seminary Drive and
8 Domingo Subdivision Road, by portion of Barangay Magugpo West and
9 Barangay Magugpo North on the Southeast along National Highway, by
10 Barangay Magugpo East and Visayan Village and on the West, by Barangay
11 Magugpo South."

12 (2) Barangay Magugpo East

13 "Beginning at a point being the junction of National Highway and
14 Apokon Road, thence; North 40-00' East, traversing the National Highway to
15 crossing New Corella Provincial Road, South 54 00' East, passing the
16 boundary between Barangay Magugpo and Barangay Magdum up to Hijo
17 River, Southwest, following down stream of Hijo River up to the South corner
18 of lot 381-B-2, Northwest direction passing the boundary between Barangay
19 Apokon, South 23 00' West, passing boundary between Zafra Subdivision,
20 Barabad Compound and Pilar Village of Barangay Apokon up to Apokon
21 Road, and North 47 30' West, passing Apokon Road to the point of beginning.
22 Bearings true.

23 "Bounded on the Northeast, by Barangay Magdum, on the Southeast, by
24 Hijo River, on the South by Barangay Apokon, on the Southwest, by Barangay
25 Visayan Village, and on the Northwest, by barangays Magugpo Poblacion and
26 Magugpo North."

27 (3) Barangay Magugpo West

28 "Beginning at a point being the junction of Pioneer Avenue and
29 Seminary Drive, thence; North 53 00' West, traversing Pioneer Avenue and

1 Pagsabangan Road up to the boundary between Barangay Magugpo and
2 Barangay Mankilam, South 45 00' East, to the road at Purok Santol connecting
3 Seminary Drive, and, South 14 00' West, following the road and Seminary
4 Drive to the point of beginning. Bearings true.

5 "Bounded on the North, by Barangay La Filipina on the East, by
6 Barangay Magugpo North on the Southeast, by Barangay Magugpo Poblacion
7 on the Southwest, by barangays Magugpo Poblacion and Magugpo South, and
8 on the Northwest, by Barangay Mankilam."

9 (4) Barangay Magugpo North

10 "Beginning at a point being the junction of National Highway and New
11 Corella Provincial Road, hence; South 40 East, passing National Highway to
12 crossing Domingo Subdivision Road, North 53 West, following Domingo
13 Subdivision Road to its junction with Seminary Drive, North 20 30 East,
14 following along Seminary Drive up to the North corner of lot 602 of Purok
15 Santol, North 79 30 East, following the boundary with Barangay La Filipina
16 up to the Provincial Road, and South 67 00 East, passing Provincial Road to
17 the point of beginning. Bearings true.

18 "Bounded on the North and Northeast, by Barangay La Filipina and
19 Barangay Magdum, on the Southeast, by Barangay Magugpo Poblacion and on
20 the Northwest, by Barangay Magugpo West."

21 (5) Barangay Magugpo South

22 "Beginning at a point being the junction of Sobrecarey Street,
23 Pagsabangan Road, Dalisay Road and Pioneer Avenue, thence; Highway,
24 South 2 30' West, traversing Sobrecarey Street, up to its junction with the
25 National Highway, South 37 30' West, passing National Highway to the South
26 corner of lot 1 owned by Vicente Gonzales, South 38 00' West, to the next
27 corner of the same lot, South 73-30', passing South of lot 715-B-2-C, owned
28 by Chiong "Oy" Uy to the South corner of lot 715-C-2 owned by Sol Ruales,
29 South 83-30' West, to the South corner of lot 2778, 721, passing further along

1 the boundaries between Sison Subdivision, Cervantes District, Teacher's
2 Village, and the barangays of San Miguel and Mankilam up to Pagsabangan
3 Road, and South 63-30' East, following Pagsabangan Road to the point of
4 beginning. Bearings true.

5 "Bounded on the Northeast, by Barangay Magugpo West, on the East,
6 by Barangay Magugpo Poblacion, on the South, by Barangay Visayan Village,
7 and on the West, by barangays San Miguel and Mankilam."

8 SEC. 3. *Conduct and Supervision of Plebiscite.* - The plebiscite
9 conducted and supervised by the Commission on Elections (COMELEC) in
10 Barangay Magugpo pursuant to Provincial Ordinance No. 2, S-1993 of the
11 Province of Davao del Norte, which ratified the division of the barangay into
12 five (5) distinct and independent barangays, namely: Barangay Magugpo
13 Poblacion, Barangay Magugpo East, Barangay Magugpo West, Barangay
14 Magugpo North and Barangay Magugpo South as proclaimed by the Plebiscite
15 Board of Canvassers on September 4, 1994, shall serve as substantial
16 compliance with the plebiscite requirement under Section 10 of Republic Act
17 No. 7160, as amended, otherwise known as the "Local Government Code of
18 1991".

19 SEC. 4. *Incumbent Barangay Officials.* - The incumbent barangay
20 officials of Barangay Magugpo Poblacion, Barangay Magugpo East, Barangay
21 Magugpo West, Barangay Magugpo North and Barangay Magugpo South of
22 the City of Tagum, Province of Davao del Norte shall continue to hold office
23 until such time that their successors have been duly elected and qualified.

24 SEC. 5. *Public Infrastructure and Facilities.* - All public infrastructure
25 and facilities for public use existing therein at the time of the approval of this
26 Act are hereby transferred without cost or compensation to and shall be
27 administered by the new barangays.

28 SEC. 6. *Internal Revenue Allotment Shares.* - All barangays herein
29 created, namely: Barangay Magugpo Poblacion, Barangay Magugpo East,

1 Barangay Magugpo West, Barangay Magugpo North and Barangay Magugpo
2 South shall be entitled to Internal Revenue Allotment (IRA) shares pursuant to
3 Section 285 of Republic Act No. 7160, as amended, otherwise known as the
4 "Local Government Code of 1991".

5 SEC. 7. *Effectivity.* – This Act shall take effect fifteen (15) days after
6 its publication in the *Official Gazette* or in a newspaper of general circulation.
