Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. In recognition of the remarkable achievements and
2 contributions of the late Anos Fonacier in the development of Bohol's tourism,
3 the Panglao Island Circumferential Road which traverses barangays Tangnan,
4 Bil-isan, Looc, Poblacion, Danao, Tawala, Bolod and Libaong in the
5 Municipality of Panglao and barangays Totolan, Songculan, Tabalong,
6 Bingag, Dao, San Isidro, Biking 1, Biking 2, Catarman, Mayacabac, Poblacion
7 and Union in the Municipality of Dauis, is hereby renamed as Anos Fonacier
8 Circumferential Road (Dauis-Panglao).

9 SEC. 2. The Department of Public Works and Highways is hereby
10 directed to implement the provision of this Act.

1 SEC. 3. This Act shall take effect (15) days after the completion of its
2 publication in the *Official Gazette* or in any newspaper of general circulation.
