



*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. Section 1 of Republic Act No. 7553 is hereby amended to
2 read as follows:

3 "SECTION. 1. [June Nineteen] MAY 15 of every year is
4 hereby declared [as] a special nonworking holiday in the
5 Province of Surigao del Norte, to be known as 'Adlaw NAN
6 PROBINSYA Nan Surigao del Norte'."

7 SEC. 2. This Act shall take effect fifteen (15) days after its publication
8 in the *Official Gazette* or in a newspaper of general circulation.

Approved.
