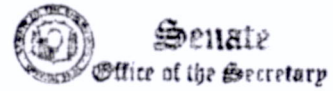

The Committee on Public Works, to which was referred House Bill No. 5001, introduced by Reps. Ferrer (L.) and Lobregat, entitled:







SORO-SORO BRIDGE IN THE CITY OF BIÑAN, PROVINCE OF
LAGUNA AND THE MUNICIPALITY OF TERNATE, PROVINCE
OF CAVITE, AS JUANITO R. REMULLA, SR. ROAD

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. The Governor's Drive, traversing Soro-Soro Bridge in the
2 City of Biñan, Province of Laguna; the municipalities of Carmona and General
3 Mariano Alvarez; the cities of Dasmariñas, General Trias and Trece Martires;
4 and the municipalities of Tanza, Naic and Ternate, Province of Cavite,
5 is hereby renamed as Juanito R. Remulla, Sr. Road.

6 SEC. 2. The Department of Public Works and Highways shall issue the
7 necessary rules, orders and circulars to implement the provision of this Act.

8 SEC. 3. This Act shall take effect fifteen (15) days after its publication
9 in the *Official Gazette* or in a newspaper of general circulation.
