AN ACT EFFECTING THE TRANSITION INTO A STATE UNIVERSITY OF SURIGAO STATE COLLEGE OF TECHNOLOGY, SIARGAO NATIONAL COLLEGE OF SCIENCE AND TECHNOLOGY, AND SURIGAO DEL NORTE COLLEGE OF AGRICULTURE AND TECHNOLOGY, ALL LOCATED IN THE PROVINCE OF SURIGAO DEL NORTE, AMENDING FOR THE PURPOSE REPUBLIC ENTITLED: ACT NO. 10600. "AN ACT SURIGAO NORTE ESTABLISHING THE DEL. STATE UNIVERSITY IN THE PROVINCE OF SURIGAO DEL NORTE BY INTEGRATING THE SURIGAO STATE COLLEGE OF TECHNOLOGY IN SURIGAO CITY, THE SIARGAO NATIONAL SCIENCE AND TECHNOLOGY IN COLLEGE OF THE MUNICIPALITY OF DEL CARMEN AND THE SURIGAO DEL NORTE COLLEGE OF AGRICULTURE AND TECHNOLOGY IN THE MUNICIPALITY OF MAINIT, ALL LOCATED IN THE PROVINCE OF SURIGAO DEL NORTE, AND APPROPRIATING FUNDS THEREFOR"

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. Section 9 of Republic Act No. 10600 is hereby amended to read as follows:

"SEC. 9. The University President. - The University shall be headed by a President, who shall render full-time service and

1	who shall be appointed by the Board, subject to the guidelines,
2	qualifications and standards set by the Board, upon
3	recommendation of a duly constituted search committee. The
4	University President shall have a term of four (4) years and shall
5	be eligible for reappointment for another term: Provided, That in
6	order to effect a smooth transition to a state university, the
7	incumbent President of the SSCT shall serve as the [Officer-in-
8	Charge] FIRST PRESIDENT of the University[, pending the
9	appointment of the first President of the University].
10	"x x x."
11	SEC. 2. Section 25 of the same Act is hereby amended to read as
12	follows:
13	"SEC. 25. Compliance with CHED Requirements
14	"x x x
15	"The institution shall retain its status prior to the effectivity
16	of this Act, unless in the meantime it is able to comply with the
17	requirements provided herein[, within a period not exceeding
18	January 1, 2016] ON OR BEFORE DECEMBER 31, 2021."
19	SEC. 3. All laws, executive orders, decrees, instructions, rules and
20	regulations contrary to or inconsistent with any provision of this Act are
21	hereby amended, repealed or modified accordingly.
2 2 .	SEC. 4. This Act shall take effect fifteen (15) days after its publication
