AN ACT RENAMING THE ILOILO STATE UNIVERSITY OF SCIENCE AND TECHNOLOGY AS THE ILOILO STATE UNIVERSITY OF FISHERIES SCIENCE AND TECHNOLOGY AND EXTENDING THE DEADLINE FOR COMPLIANCE OF THE ILOILO STATE UNIVERSITY OF SCIENCE AND TECHNOLOGY INTO A STATE UNIVERSITY WITH THE REQUIREMENTS OF THE COMMISSION ON HIGHER EDUCATION, THEREBY AMENDING REPUBLIC ACT NO. 10604, ENTITLED: "AN ACT CONVERTING THE ILOILO STATE COLLEGE OF FISHERIES IN THE MUNICIPALITY OF BAROTAC NUEVO, PROVINCE OF ILOILO INTO A STATE UNIVERSITY TO BE KNOWN AS THE ILOILO STATE UNIVERSITY OF SCIENCE AND TECHNOLOGY, WITH CAMPUSES IN THE MUNICIPALITIES OF SAN ENRIOUE, DINGLE AND DUMANGAS. AND BAROTAC THEREWITH THE NUEVO INTEGRATING INSTITUTE IN THE MUNICIPALITY OF POLYTECHNIC BAROTAC NUEVO, ALL LOCATED IN THE PROVINCE OF ILOILO AND APPROPRIATING FUNDS THEREFOR"

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

Nuevo, Province of Iloilo, including its campuses, namely:

SECTION 1. Section 1 of Republic Act No. 10604 is hereby amended to read as follows:

"SECTION 1. Conversion. – The Iloilo State College of Fisheries (ISCOF) in the Municipality of Barotac
