



AN ACT SEPARATING THE SITIOS OF ILEB, NEW COLAYO VILLAGE, KINAMA AND NAMBARAN DAYA FROM BARANGAY NAMBARAN, CITY OF TABUK, PROVINCE OF KALINGA AND CONSTITUTING THEM INTO A SEPARATE AND INDEPENDENT BARANGAY TO BE KNOWN AS BARANGAY NAMBARAN EAST

*Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:*

1           SECTION 1. *Creation of Barangay Nambaran East.* – The sitios of  
2   Ileb, New Colayo Village, Kinama and Nambaran Daya are hereby separated  
3   from Barangay Nambaran in the City of Tabuk, Province of Kalinga to  
4   constitute a separate and independent barangay to be known as Barangay  
5   Nambaran East.

6           The territorial boundaries of Barangay Nambaran East are hereby  
7   described as follows:

8           “Bounded on the East by the Municipality of Rizal; on the South by  
9   Barangay Lacnog; on the West by Barangay Nambaran; and on the Northwest  
10   by Barangay Dilag.”

11          SEC. 2. *Conduct and Supervision of Plebiscite.* – Pursuant to Section  
12   10 of Republic Act No. 7160, as amended, otherwise known as the “Local

1 Government Code of 1991", the new Barangay Nambaran East shall exist  
2 upon the approval by a majority of the votes cast by the qualified voters of  
3 Barangay Nambaran in a plebiscite to be conducted and supervised by the  
4 Commission on Elections (COMELEC) in the area affected, within ninety (90)  
5 days from the effectivity of this Act.

6 The amount necessary for the conduct of such plebiscite shall be borne  
7 by the City of Tabuk, Province of Kalinga.

8 SEC. 3. *Barangay Officials.* – The first set of officials of Barangay  
9 Nambaran East shall be appointed by the Provincial Governor and shall hold  
10 office until such time that their successors have been duly elected and  
11 qualified.

12 SEC. 4. *Public Infrastructure and Facilities.* – All public  
13 infrastructure and facilities for public use existing therein at the time of the  
14 approval of this Act are hereby transferred without cost or compensation to  
15 and shall be administered by the new barangay.

16 SEC. 5. *Internal Revenue Allotment Shares.* – Barangay Nambaran  
17 East shall be entitled to Internal Revenue Allotment (IRA) shares pursuant to  
18 Section 285 of Republic Act No. 7160, as amended, otherwise known as the  
19 "Local Government Code of 1991".

20 SEC. 6. *Effectivity.* – This Act shall take effect fifteen (15) days after  
21 its publication in the *Official Gazette* or in a newspaper of general circulation.
