AN ACT [REAPPORTIONING THE SIXTH AND SEVENTH LEGISLATIVE DISTRICTS OF THE PROVINCE OF CAVITE TO CREATE AN ADDITIONAL LEGISLATIVE DISTRICT TO BE KNOWN AS THE EIGHTH LEGISLATIVE DISTRICT OF THE PROVINCE OF CAVITE] **AMENDING SECTION 1 OF REPUBLIC ACT NO. 9727, REAPPORTIONING THE PROVINCE OF CAVITE INTO EIGHT (8) LEGISLATIVE DISTRICTS**

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 [SECTION 1. *Reapportionment of the Sixth and Seventh Legislative*
2 *Districts.* – The Sixth and Seventh Legislative Districts of the Province of
3 Cavite are hereby reapportioned to create the Eighth Legislative District as
4 follows:

5 (a) The Sixth Legislative District shall be composed of the City of
6 General Trias;

7 (b) The Seventh Legislative District shall be composed of the City of
8 Trece Martires, and the municipalities of Amadeo, Tanza and Indang; and

1 (c) The Eighth Legislative District shall be composed of the City of
2 Tagaytay, and the municipalities of Alfonso, General Emilio Aguinaldo,
3 Magallanes, Maragondon, Mendez, Naic and Ternate.]

4 **SECTION 1. SECTION 1 OF REPUBLIC ACT NO. 9727 IS**
5 **HEREBY AMENDED TO READ AS FOLLOWS:**

6 "SECTION 1. Legislative Districts. – The Province of Cavite, which
7 shall have [seven (7)] **EIGHT (8)** legislative districts to commence on the next
8 national **AND LOCAL** elections after the effectivity of this Act, is hereby
9 reapportioned as follows:

10 **FIRST LEGISLATIVE DISTRICT**

- 11 (1) Cavite City
12 (2) Kawit
13 (3) Noveleta
14 (4) Rosario

15 **SECOND LEGISLATIVE DISTRICT**

- 16 (1) Bacoor **CITY**

17 **THIRD LEGISLATIVE DISTRICT**

- 18 (1) Imus **CITY**

19 **FOURTH LEGISLATIVE DISTRICT**

- 20 (1) Dasmariñas **CITY**

21 **FIFTH LEGISLATIVE DISTRICT**

- 22 (1) Carmona
23 (2) General Mariano Alvarez (GMA)

25 **SIXTH LEGISLATIVE DISTRICT**

- 26 (1) **GENERAL TRIAS CITY**

12 [SEC. 2. *Commencement of Reapportioned Legislative Districts.* – The
13 reapportioned legislative districts under Section 1 hereof shall commence in
14 the next national and local elections after the effectivity of this Act.]

15 SEC. [3] 2. *Incumbent Representatives.* – The incumbent Representatives
16 of the Sixth and Seventh Legislative Districts of the Province of Cavite shall
17 continue to represent their respective legislative districts until the new
18 Representative shall have been elected and qualified.

19 SEC. [4] 3. *Rules and Regulations.* – The Commission on Elections
20 shall issue the necessary rules and regulations within thirty (30) days upon the
21 approval of this Act.

22 SEC. [5] 4. *Repealing Clause.* – Republic Act No. 9727 and all other
23 laws, rules and regulations which are inconsistent with this Act are hereby
24 repealed, amended or modified accordingly.

25 SEC. [6] 5. *Effectivity.* – This Act shall take effect fifteen (15) days
26 after its publication in the *Official Gazette* or in a newspaper of general
27 circulation.
