AN ACT ESTABLISHING A LAND TRANSPORTATION OFFICE (LTO)
SATELLITE OFFICE IN TICAO ISLAND, PROVINCE OF
MASBATE AND APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. There shall be established a Land Transportation Office
2 (LTO) Satellite Office in Ticao Island, Province of Masbate to be known as
3 the LTO Ticao Satellite Office.

4 SEC. 2. The Secretary of Transportation shall immediately include in
5 the Department's program the operationalization of the LTO Satellite Office in
6 Ticao Island, Province of Masbate, the funding of which shall be included in
7 the annual General Appropriations Act.

8 SEC. 3. The Secretary of Transportation shall issue the necessary rules
9 and regulations for the effective implementation of this Act.

10 SEC. 4. This Act shall take effect fifteen (15) days after its publication
11 in the *Official Gazette* or in a newspaper of general circulation.
