#### MR. PRESIDENT:

The Committees on Local Government; and Electoral and People's Participation, to which was referred House Bill No. **4942**, introduced by Representative Maximo B. Dalog entitled:

# "AN ACT CREATING A BARANGAY TO BE KNOWN AS BARANGAY PUDO IN THE MUNICIPALITY OF NATONIN, MOUNTAIN PROVINCE"

have considered the same and have the honor to report it back to the Senate with the

recommendation that it be approved with the following amendments:

1. On page 1, line 4, before Sec. 2 (Conduct and Supervision of Plebiscite), insert a

new section to read as follows:

"SEC. 2. TERRITORIAL BOUNDARIES. – THE TERRITORIAL BOUNDARIES OF BARANGAY PUDO SHALL BE IDENTIFIED AS FOLLOWS:

Bounded on the Northeast (NE) along line 1 to 2 by Barangay Alunogan; On the Southeast (SE) along line 2 to 6 by Barangay Alunogan; On the Southwest (SE) along line 6 to 12 by Barangay Tonglayan; On the Southwest (SW) along line 12 to 15 by Barangay Tonglayan; On the Northeast (NE) along line 15 to 1 by Tanudan River.

## AN ACT CREATING A BARANGAY TO BE KNOWN AS BARANGAY PUDO IN THE MUNICIPALITY OF NATONIN, MOUNTAIN PROVINCE

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. Creation of Barangay Pudo. - There is hereby created a
barangay to be known as Barangay Pudo in the Municipality of Natonin,
Mountain Province.

4 SEC. 2. Conduct and Supervision of Plebiscite. - The plebiscite conducted and supervised by the Commission on Elections (COMELEC) 5 pursuant to Provincial Ordinance No. 1-S-91 of the Sangguniang Panlalawigan 6 of Mountain Province, which ratified the creation of Barangay Pudo as 7 proclaimed by the Plebiscite Board of Canvassers on December 2, 1994, shall .8 9 serve as substantial compliance with the plebiscite requirement under 10 Section 10 of Republic Act No. 7160, as amended, otherwise known as the "Local Government Code of 1991". 11

SEC. 3. Incumbent Barangay Officials. - The incumbent barangay
officials of Barangay Pudo, Municipality of Natonin, Mountain Province shall
continue to hold office until such time that their successors have been duly
elected and qualified.

1 SEC. 4. *Public Infrastructure and Facilities.* – All public infrastructure 2 and facilities for public use existing therein at the time of the approval of this 3 Act are hereby transferred without cost or compensation to and shall be 4 administered by the new barangay.

5 SEC. 5. Internal Revenue Allotment Shares. – Barangay Pudo shall be 6 entitled to Internal Revenue Allotment (IRA) shares pursuant to Section 285 of 7 Republic Act No. 7160, as amended, otherwise known as the "Local 8 Government Code of 1991".

SEC. 6. Effectivity. - This Act shall take effect fifteen (15) days after its publication in the Official Gazette or in a newspaper of general circulation. Approved,
