Re: House Bill No. **2924**

Recommending its approval with amendment.

Sponsor: Senator Angara

MR. PRESIDENT:

The Committees on Local Government; and Electoral and People's Participation, to which was referred House Bill No. **2924**, introduced by Representative Noel L. Villanueva entitled:

"AN ACT CREATING A BARANGAY TO BE KNOWN AS BARANGAY CRISTO REY IN THE MUNICIPALITY OF CAPAS, PROVINCE OF TARLAC"

have considered the same and have the honor to report it back to the Senate with the recommendation that it be approved with the following amendment:

1. On page 1, delete lines 7-15 and in lieu thereof, insert a new section to read as follows:

"SEC. 2. TERRITORIAL BOUNDARIES. – THE TERRITORIAL BOUNDARIES OF BARANGAY CRISTO REY SHALL BE IDENTIFIED AS FOLLOWS:

Bounded on the Northwest (NW) and Northeast (NE) pts 1 to 4 and 16 by Capas Cadastre Cad 615-D Case 11 Barangay Lawy (Pb-03-000024-D);

On the Northeast (NE) pts 4 and 5 by Capas Cadastre Cad 615-D Case 12; Barangay Aranguren (Pb-03-000024-D);
 On the Southeast (SE) and Southwest (SW) pts 5 to 15 by Provincial Road;
 On the South West along line 15-16 by Capas Cadastre Cad 615-D Case 12 Barangay Aranguren (Pb-03-000024-D), all of Municipality of Capas;

The Technical Description of Barangay Cristo Rey is as follows:



AN ACT CREATING A BARANGAY TO BE KNOWN AS BARANGAY
CRISTO REY IN THE MUNICIPALITY OF CAPAS, PROVINCE OF
TARLAC

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. *Creation of Barangay Cristo Rey.* — The O'Donnell
2 Resettlement Area in Barangay Aranguren, Municipality of Capas, Province of
3 Tarlac which was separated from Barangay Aranguren and constituted as a
4 distinct and independent barangay under Provincial Ordinance No. 004-2003
5 in 2003 is hereby created and shall hereafter be known as Barangay Cristo
6 Rey.

7 The technical description of Barangay Cristo Rey shall be as follows:

8 "Bounded on the East along line 1-2 by lot 1904, line 2-3 by lot 1903,
9 both in Capas Cadastre; on the South along lines 3-4; 4-5; 5-6; 6-7; 7-8; 8-9;
10 9-10; 10-11; and 11-12 by the Provincial Road to O'Donnell and beyond by the
11 portion of the reservation; and on the West and North along lines 12-13 and
12 13-14 by the portion of the reservation; and on the East by lot 1706 of Capas
13 Cadastre. Beginning at a point marked "1" on the stretch plan being identical
14 to BBM No. 48 of Capas Cadastre; covering an area of 348.27 hectares more
15 or less."

1 SEC. 2. *Conduct and Supervision of Plebiscite.* – The plebiscite
2 conducted and supervised by the Commission on Elections (COMELEC) in
3 Barangay Aranguren pursuant to Provincial Ordinance No. 004-2003 of the
4 Sangguniang Panlalawigan of the Province of Tarlac, which ratified the
5 creation of Barangay Cristo Rey as proclaimed by the Plebiscite Board of
6 Canvassers on December 13, 2003, shall serve as substantial compliance with
7 the plebiscite requirement under Section 10 of Republic Act No. 7160, as
8 amended, otherwise known as the “Local Government Code of 1991”.

9 SEC. 3. *Incumbent Barangay Officials.* – The incumbent barangay
10 officials of Barangay Cristo Rey shall continue to hold office until such time
11 that their successors have been duly elected and qualified.

12 SEC. 4. *Public Infrastructure and Facilities.* – All public
13 infrastructure and facilities for public use existing therein at the time of the
14 approval of this Act are hereby transferred without cost or compensation to
15 and shall be administered by the new barangay.

16 SEC. 5. *Internal Revenue Allotment Shares.* – Barangay Cristo Rey
17 shall be entitled to Internal Revenue Allotment (IRA) shares pursuant to
18 Section 285 of Republic Act No. 7160, as amended, otherwise known as the
19 “Local Government Code of 1991”.

20 SEC. 6. *Effectivity.* – This Act shall take effect fifteen (15) days after
21 its publication in the *Official Gazette* or in a newspaper of general circulation.
