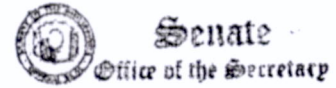

OF LANA DEL NORTE AS THE ARSENIO ARCELO
QUIBRANZA HIGHWAY

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. The Poblacion-Caniogan National Road traversing
2 barangays Poblacion, San Antonio, Patudan, Pinpin, Malingao, Licapao,
3 Candis, Caniogan and Barakanas in the Municipality of Tubod, Province of
4 Lanao del Norte, is hereby named as the Arsenio Arcelo Quibranza Highway.

5 SEC. 2. The Department of Public Works and Highways shall issue the
6 necessary rules, orders, and circulars to implement the provision of this Act.

7 SEC. 3. This Act shall take effect fifteen (15) days following the
8 completion of its publication in the *Official Gazette* or in a newspaper of
9 general circulation.
