MR. PRESIDENT:

The Committee on Education, Arts and Culture to which was referred House Bill No. 5150, introduced by Reps. Matugas, Barbers and Hofer, entitled:

"AN ACT EFFECTING THE TRANSITION INTO A STATE UNIVERSITY OF SURIGAO STATE COLLEGE OF TECHNOLOGY, SIARGAO NATIONAL COLLEGE OF SCIENCE AND TECHNOLOGY, AND SURIGAO DEL NORTE COLLEGE OF AGRICULTURE AND TECHNOLOGY, ALL LOCATED IN THE PROVINCE OF SURIGAO DEL NORTE, AMENDING FOR THE PURPOSE REPUBLIC ACT NO. 10600, ENTITLED: "AN ACT ESTABLISHING THE SURIGAO DEL NORTE STATE UNIVERSITY IN THE PROVINCE OF SURIGAO DEL NORTE BY INTEGRATING THE SURIGAO STATE COLLEGE OF TECHNOLOGY IN SURIGAO CITY, THE SIARGAO NATIONAL COLLEGE OF SCIENCE AND TECHNOLOGY IN THE MUNICIPALITY OF DEL CARMEN AND THE SURIGAO DEL NORTE COLLEGE OF AGRICULTURE AND TECHNOLOGY IN THE MUNICIPALITY OF MAINIT, ALL LOCATED IN THE PROVINCE OF SURIGAO DEL NORTE, AND APPROPRIATING FUNDS THEREFOR"

has considered the same and has the honor to report it back to the Senate with the recommendation that it be approved with the following amendments:

- 1. ON PAGE 2, LINE 16, DELETE THE COMMA (,) FOLLOWING THE WORD "ACT".
- 2. ON THE SAME PAGE AND LINE, DELETE THE PHRASE "UNLESS IN THE MEANTIME" AND IN LIEU THEREOF, INSERT THE WORD "UNTIL".
- 3. ON THE SAME PAGE AND PARAGRAPH, LINE 18, DELETE THE PHRASE "ON OR BEFORE DECEMBER 31, 2021".

THE PARAGRAPH SHALL NOW READ AS FOLLOWS:

"THE INSTITUTION SHALL RETAIN ITS STATUS PRIOR TO THE EFFECTIVITY OF THIS ACT UNTIL IT IS ABLE TO COMPLY WITH THE REQUIREMENTS PROVIDED HEREIN."

- 4. IN THE TITLE, DELETE THE PHRASE "EFFECTING THE TRANSITION INTO A STATE UNIVERSITY OF SURIGAO STATE COLLEGE OF TECHNOLOGY, SIARGAO NATIONAL COLLEGE OF SCIENCE AND TECHNOLOGY, AND SURIGAO DEL NORTE COLLEGE OF AGRICULTURE AND TECHNOLOGY, ALL LOCATED IN THE PROVINCE OF SURIGAO DEL NORTE,"
- 5. ALSO IN THE TITLE, AFTER THE WORD "AMENDING", DELETE THE PHRASE "FOR THE PURPOSE".

THE TITLE SHAL NOW READ AS FOLLOWS:

"AN ACT AMENDING REPUBLIC ACT NO. 10600, ENTITLED: "AN ACT ESTABLISHING THE SURIGAO DEL NORTE STATE UNIVERSITY IN THE PROVINCE OF SURIGAO DEL NORTE BY INTEGRATING THE SURIGAO STATE COLLEGE OF TECHNOLOGY IN SURIGAO CITY, THE SIARGAO NATIONAL COLLEGE OF SCIENCE AND TECHNOLOGY IN THE MUNICIPALITY OF DEL CARMEN AND THE SURIGAO DEL NORTE COLLEGE OF AGRICULTURE AND TECHNOLOGY IN THE MUNICIPALITY OF MAINIT, ALL LOCATED IN THE PROVINCE OF SURIGAO DEL NORTE, AND APPROPRIATING FUNDS THEREFOR"

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. Section 9 of Republic Act No. 10600 is hereby amended to read as follows:

"SEC. 9. The University President. - The University shall be headed by a President, who shall render full-time service and
