MR. PRESIDENT:

The Committee on Education, Arts and Culture to which was referred House Bill No. 5147, introduced by Reps. Gullas and Hofer, entitled:

**"AN ACT CONVERTING THE TALISAY CITY COLLEGE IN THE CITY OF TALISAY, PROVINCE OF CEBU INTO THE TALISAY CITY STATE COLLEGE, AMENDING FOR THE PURPOSE REPUBLIC ACT NO. 10594, ENTITLED: "AN ACT ESTABLISHING A STATE COLLEGE IN THE CITY OF TALISAY, PROVINCE OF CEBU TO BE KNOWN AS THE TALISAY CITY STATE COLLEGE, AND APPROPRIATING FUNDS THEREFOR"**

has considered the same and has the honor to report it back to the Senate with the recommendation that it be approved with the following amendments:

1. ON PAGE 2, LINE 15, DELETE THE COMMA (,) FOLLOWING THE WORD "ACT".
2. ON THE SAME PAGE AND LINE, DELETE THE PHRASE "UNLESS IN THE MEANTIME" AND IN LIEU THEREOF, INSERT THE WORD "UNTIL".
3. ON THE SAME PAGE AND PARAGRAPH, LINES 17 AND 18, DELETE THE PHRASE "ON OR BEFORE DECEMBER 31, 2021".

THE PARAGRAPH SHALL NOW READ AS FOLLOWS:

"THE INSTITUTION SHALL RETAIN ITS STATUS PRIOR TO THE EFFECTIVITY OF THIS ACT UNTIL IT IS ABLE TO COMPLY WITH THE REQUIREMENTS PROVIDED HEREIN."





AN ACT CONVERTING THE TALISAY CITY COLLEGE IN THE CITY OF TALISAY, PROVINCE OF CEBU INTO THE TALISAY CITY STATE COLLEGE, AMENDING FOR THE PURPOSE REPUBLIC ACT NO. 10594, ENTITLED: "AN ACT ESTABLISHING A STATE COLLEGE IN THE CITY OF TALISAY, PROVINCE OF CEBU TO BE KNOWN AS THE TALISAY CITY STATE COLLEGE, AND APPROPRIATING FUNDS THEREFOR"

*Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:*

1           SECTION 1. Section 1 of Republic Act No. 10594 is hereby amended  
2 to read as follows:

3                   "SECTION 1. *Establishment.* – There is hereby established  
4 a state college in the City of Talisay, Province of Cebu [to be  
5 known as the Talisay City State College] BY CONVERTING THE  
6 TALISAY CITY COLLEGE INTO THE TALISAY CITY STATE  
7 COLLEGE IN THE CITY OF TALISAY, PROVINCE OF CEBU,  
8 hereinafter referred to as the College. ITS MAIN CAMPUS SHALL  
9 BE IN THE CITY OF TALISAY, PROVINCE OF CEBU."

1           SEC. 2. Section 24 of Republic Act No. 10594 is hereby  
2 amended to read as follows:

3           "SEC. 24. *Compliance with CHED Requirements.* -

4           "x x x

5           "The following are the operational requirements for a  
6 college:

7           "(a) [Level III accreditation or equivalent under CHED  
8 policies for at least four (4) of its undergraduate programs, one  
9 (1) in liberal arts and one (1) in the sciences, and two (2) of its  
10 graduate programs] **THE APPROPRIATE OR EQUIVALENT  
11 ACCREDITATION UNDER CHED POLICIES AND GUIDELINES  
12 FOR COLLEGES;**

13           "x x x

14           "The institution shall retain its status prior to the  
15 effectivity of this Act, unless in the meantime it is able to  
16 comply with the requirements provided herein[, within a period  
17 not exceeding January 1, 2016] **ON OR BEFORE DECEMBER 31,  
18 2021.**"

19           SEC. 3. The title of Republic Act No. 10594 is hereby amended to read  
20 as follows:

21           **"AN ACT CONVERTING THE TALISAY CITY COLLEGE IN  
22 THE CITY OF TALISAY, PROVINCE OF CEBU INTO THE TALISAY  
23 CITY STATE COLLEGE, AMENDING FOR THE PURPOSE  
24 REPUBLIC ACT NO. 10594, ENTITLED: "AN ACT  
25 ESTABLISHING A STATE COLLEGE IN THE CITY OF TALISAY,  
26 PROVINCE OF CEBU TO BE KNOWN AS THE TALISAY CITY  
27 STATE COLLEGE, AND APPROPRIATING FUNDS THEREFOR".**

1           SEC. 4. All laws, executive orders, decrees, instructions, rules and  
2 regulations contrary to or inconsistent with any provision of this Act are  
3 hereby amended, repealed or modified accordingly.

4           SEC. 5. This Act shall take effect fifteen (15) days after its publication  
5 in the *Official Gazette* or in a newspaper of general circulation.
