## HOUSE OF REPRESENTATIVES

AN ACT ESTABLISHING A NATIONAL HIGH SCHOOL IN BARANGAY HAMPANGAN, MUNICIPALITY OF HILONGOS, PROVINCE OF LEYTE TO BE KNOWN AS HAMPANGAN NATIONAL HIGH SCHOOL AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

- SECTION 1. There is hereby established, under the supervision of the
- Department of Education, a national high school in Barangay Hampangan,
- 3 Municipality of Hilongos, Province of Leyte to be known as Hampangan
- National High School.
- SEC. 2. The Secretary of Education shall immediately include in the
- 6 Department's program the operationalization of the Hampangan National High
- 7 School, the funding of which shall be included in the annual General
- 8 Appropriations Act.
- 9 SEC. 3. The Secretary of Education shall formulate the rules and
- 10 regulations implementing the provisions of this Act within one hundred
- .11 twenty (120) days after its effectivity.

- 1 SEC. 4. This Act shall take effect fifteen (15) days after its publication
- 2 in the Official Gazette or in a newspaper of general circulation. Approved,
