*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

1           SECTION 1. There is hereby established, under the supervision of  
2 the Department of Education, a national high school in Barangay Paso  
3 De Blas, Valenzuela City to be known as Paso De Blas National High  
4 School.

5           SEC. 2. The Secretary of Education shall immediately include in the  
6 Department's program the operationalization of the Paso De Blas  
7 National High School, the funding of which shall be included in the annual  
8 General Appropriations Act.

9           SEC. 3. The Secretary of Education shall formulate the rules  
10 and regulations implementing the provisions of this Act within  
11 one hundred twenty (120) days after its effectivity.

1           SEC. 4. This Act shall take effect fifteen (15) days after  
2 its publication in the *Official Gazette* or in a newspaper of  
3 general circulation.
