NATIONAL HIGH SCHOOL AND APPROPRIATING FUNDS
THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. There is hereby established, under the supervision of
2 the Department of Education, a national high school in Barangay Manlilisid,
3 Municipality of Javier, Province of Leyte to be known as Manlilisid
4 National High School.

5 SEC. 2. The Secretary of Education shall immediately include in the
6 Department's program the operationalization of the Manlilisid
7 National High School, the funding of which shall be included
8 in the annual General Appropriations Act.

9 SEC. 3. The Secretary of Education shall formulate the rules and
10 regulations implementing the provisions of this Act within one hundred
11 twenty (120) days after its effectivity.

1 SEC. 4. This Act shall take effect fifteen (15) days after
2 its publication in the *Official Gazette* or in a newspaper of
3 general circulation.

EXPLANATORY NOTE

The 1987 Constitution provides that the State shall protect and promote the rights of all citizens to quality education at all levels and shall take necessary and appropriate steps to make education accessible to all. The Constitution likewise mandates the State to establish and maintain a system of free education in the elementary and high school levels.

This bill proposes to formally establish a National High School in Barangay Manlilisid, Municipality of Javier, Province of Leyte to be known as Manlilisid National High School. There is an evident need for the formal establishment of the requested high school in this part of the Municipality. For the longest time, students have to go to Javier National High School that is nine (9) kilometers away via the Javier Circumferential Road. The establishment of Manlilisid National High School will greatly benefit the students of Barangay Manlilisid including seven (7) nearby localities namely, Barangays San Sotero, Comatin, Caraye, Oding, Cancayang, Abuyogay and Caranhug.

This proposed measure aims to do justice to the youth of this Barangay and its neighboring communities by providing them the opportunity to liberate themselves from illiteracy and eventually upgrade their social and economic status without compromising their safety and well-being.

In view of foregoing, approval of this worthy measure is earnestly sought.

HOUSE BILL NO **4486**

AN ACT

ESTABLISHING A NATIONAL HIGH SCHOOL IN BARANGAY MANLILISID, MUNICIPALITY OF JAVIER, PROVINCE OF LEYTE TO BE KNOWN AS MANLILISID NATIONAL HIGH SCHOOL AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. There is hereby established, under the supervision of the Department of Education, a National High School in Barangay Manlilisid, Municipality of Javier, Province of Leyte to be known as Manlilisid National High School.

SECTION 2. The amount necessary for the establishment of said National High School shall be funded out of the appropriations of the Department of Education. The sum necessary for its operation and maintenance shall be included in the annual General Appropriations Act of the year following its enactment into law and thereafter.

SECTION 3. The Secretary of Education is hereby authorized to issue such rules and regulations as may be necessary to carry out the purpose of this Act.

SECTION 4. This Act shall take effect upon its approval.
