AN ACT ESTABLISHING A REGULAR DISTRICT OFFICE OF  
THE LAND TRANSPORTATION OFFICE (LTO) IN THE  
CITY OF PANABO, PROVINCE OF DAVAO DEL NORTE  
AND APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

1           SECTION 1. There shall be established, under the supervision of the  
2 Department of Transportation (DOTr), a regular district office of the  
3 Land Transportation Office (LTO) in the City of Panabo, Province of  
4 Davao del Norte, to be known as the "Panabo City Land Transportation  
5 Regular District Office".

6           SEC. 2. The Secretary of the DOTr shall immediately include in  
7 the Department's programs the operationalization of the LTO regular  
8 district office in the City of Panabo, Province of Davao del Norte, the  
9 funding of which shall be included in the annual General Appropriations Act.

1           SEC. 3. The Secretary of the DOTr shall issue the necessary rules and  
2 regulations within ninety (90) days from the effectivity of this Act.

3           SEC. 4. This Act shall take effect fifteen (15) days after its publication  
4 in the *Official Gazette* or in two (2) newspapers of general circulation.
