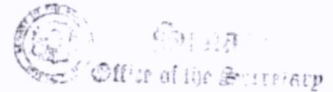



AN ACT CONVERTING THE SATELLITE OFFICE OF THE LAND
TRANSPORTATION OFFICE (LTO) IN THE CITY OF BAYUGAN,
PROVINCE OF AGUSAN DEL SUR, INTO A REGULAR
DISTRICT OFFICE, AND APPROPRIATING FUNDS THEREFOR

*Be It enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. The Satellite Office of the Land Transportation Office
2 (LTO) in the City of Bayugan, Province of Agusan del Sur, is hereby
3 converted into a regular district office to be known as the LTO District Office.

4 SEC. 2. The Secretary of Transportation shall include in the
5 Department's program the operationalization of the LTO district office in the
6 City of Bayugan, Province of Agusan del Sur, the funding of which shall be
7 included in the annual General Appropriations Act.

8 SEC. 3. This Act shall take effect fifteen (15) days after its publication
9 in the *Official Gazette* or in a newspaper of general circulation.
