





AN ACT CONVERTING THE LAND TRANSPORTATION OFFICE (LTO)
LOCATED IN THE MUNICIPALITY OF BALAYAN, PROVINCE
OF BATANGAS INTO A REGULAR LTO DISTRICT OFFICE TO
BE KNOWN AS THE LTO DISTRICT OFFICE OF BALAYAN,
BATANGAS AND APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. The Extension Office of the Land Transportation Office
2 (LTO) in the Municipality of Balayan, Batangas is hereby converted into a
3 Regular LTO District Office to be known as the LTO District Office of
4 Balayan, Batangas.

5 SEC. 2. The Secretary of the Department of Transportation shall
6 immediately include in the Department's program the operationalization of a
7 Regular LTO District Office in the Municipality of Balayan, Batangas, the
8 initial funding of which shall be charged against the current year's
9 appropriation of the Balayan LTO Extension Office located in the
10 Municipality of Balayan, Batangas. Thereafter, such sums as may be
11 necessary for the continued operation of the Regular LTO District Office shall
12 be included in the annual General Appropriations Act.

1 SEC. 3. The Secretary of the Department of Transportation shall
2 promulgate the rules and regulations necessary for the effective
3 implementation of this Act.

4 SEC. 4. This Act shall take effect fifteen (15) days after its publication
5 in at least two (2) newspapers of general circulation.
