PRIVILEGE SPEECH OF SENATOR AQUINO

Availing himself of the privilege hour, Senator Aquino called the Body's attention to the fatal shooting of 17-year old Kian Loyd D. delos Santos during the PNP's Oplan Galugad anti-drug operation in Caloocan City.

Following is the full text of Senator Aquino's privilege speech:

"Ian, isara mo na ang tindahan at matulog ka na." Kung alam lamang po sana ni Lola Violeta na iyan ang huling masasabi niya sa kanyang apo, siguro po iba ang nabigkas niya.

Bumaba si po Ian upang isara ang sarisari store ng pamilya at naglinis muna bago matulog. Kung alam lamang po sana ni Ian kung anong tadhana ang nag-aantay sa kanya, siguro ay hindi na siya nagkusang-loob.

As someone who has worked in the youth sector for more than a decade, and as someone who, like all of us here, pushed for more access to education for our Filipino youth, the unnecessary death of Ian delos Santos was difficult to accept.

Noong nabalitaan ko na sa Oplan Galugad ng PNP, may Grade 11 student na—kitang kita naman sa CCTV footage—na kinaladkad patungong isang sulok at pinatay na walang pakundangan, nanghina po ang aking loob at napaisip ako.

Paano tayo umabot sa ganito? Ito na ba ang "new normal" ng ating bansa, especially sa mga mahihirap na barangay sa ating bayan?

Many of us here, surely, felt the same way.

Marami po sa mga kababayan natin ang



una nalungkot, at pagkatapos, nagalit sa nangyari kay Ian at sa kaniyang pamilya.

Kian Loyd delos Santos, better known as Ian to his friends, is a 17-year old Grade 11 student from Our Lady of Lourdes Senior High School. Si Ian po ay pangatlo sa apat na anak. Sari-sari store owner ang kanyang amang si Zaldy at nagtatrabaho sa Riyadh bilang OFW ang kanyang ina na si Lorenza.

"Kapit lang, Ma, makakauwi ka na. Malapit na akong matapos sa pag-aaral," pangako po ni Ian. Mabuti po siyang anak. Araw-araw, gumigising nang maaga si Ian upang magbenta ng school supplies sa mga estudyante at magulang na naglalakad papunta sa paaralang malapit sa kanila.

"Kilala si Ian na nagbebenta—nagbebenta ng school supplies sa mga dumadaan sa aming tindahan, hindi droga," giit po ng kanyang ama.

Masipag din po siyang estudyante. "Sabaysabay tayong magtatapos ng high school," pahayag ni Ian nang bumuo siya ng study group kasama ng kanyang mga kaklase.

Si Ian ay masayahin at malambing, magaling sumayaw — according sa kanyang barkada, mahilig sa FLIPTOP, at idol ang Filipino battle rapper na si Bassilyo.

Higit sa lahat, si Ian ay mapagmahal na kaibigan. Ramdam na ramdam ko po ang pagmamahal ng kanyang mga kaibigan nung nakasama ko sila kahapon sa burol ni Ian. Ang ilan po sa kanila ay kasama natin ngayong hapong ito.

"Naglalaba ka na naman? Sabi ko sa 'yo maupo ka lang eh," lagi pong nasasabi ni Ian sa kaniyang kaibigang si Erica. At siya na po ang magtatapos ng labada ni Erica.

Sabi naman ni Ian kay Lennard, ang kanyang best friend, "Pumasok ka na, Go! Miss na kita."

"Awang awa si Ian sa akin noong inopera ako," kuwento ni Lennard, "Wala siyang pambili ng pagkain, pero binenta niya ang kaniyang mga damit para makabili lang ng prutas para sa akin. Pinilit kong pumasok agad para kay Ian, para makabawi ako sa kanya. Miss na daw niya ako."

Ramdam na ramdam ng mga kaibigan ni Ian ang kaniyang pagmamahal.

Hangarin sana ni Ian na i-ahon ang kanyang pamilya mula sa kahirapan.

Nangarap si Ian maging pulis, ngunit sa kaduluduluhan, mga pulis din po ang kumuha ng kanyang buhay. Isang tama ng bala sa likuran, dalawa sa kanyang tenga, patunay, sabi sa kanyang autopsy, na binaril siya habang nakahandusay sa lupa.

Ang sigaw niya po sa kabila ng kahirapan sa buhay, "Laban lang!"

Ngunit hindi siya nanlaban. Hindi po siya nanlaban. Hindi po siya nanlaban.

Noong Miyerkules, ikalabing-anim ng Agosto, alas otso bente kuwatro ng gabi, pinatay ng mga pulis si Kian Loyd Delos Santos na walang kalaban-laban, sa ngalan po ng giyera kontra droga.

"Tama na po! Tama na po! May test pa ako bukas!", narinig ng mga testigo na sabi raw po ni Ian habang siya ay kinakaladkad patungong isang madilim na sulok sa looban ng Caloocan.

Kung kinilala sana ng mga pulis na 'yon ang Ian na kilala natin ngayon—

Ang Ian na gumigising nang maaga upang matulungan ang ama para magbenta ng school supplies;

Ang Ian na tumutulong kay Erica tuwing Sabado sa kanyang gawaing bahay;

Ang Ian na nagbenta ng damit para lang makabili ng prutas para sa kanyang kaibigang si Lennard na bagong opera;

Ang Ian na may talento sa pagsayaw at pambato ng kanilang klase sa mga folk dancing competition;

Ang lan na nagsisikap makapagtapos ng pag-aaral at nangarap makapasok sa PNPA.

Kung yon po sana ang nakilala nila at hindi isang ang sinasabi ho nilang drug addict o drug courier na sa tingin po ng iba ay hindi naman tao at walang karapatang mabuhay, siguro po buhay pa si Ian ngayon — nangangarap at nagsisikap, nagpapasaya at tumutulong sa kanyang mga kaibigan at kapamilya.

Thousands of Filipinos have died in the name of this current drug war we have. Just last week, there were 81 recorded killings.

Collateral damage in previous months included children as young as four years old... killed in the hands of those who have sworn to serve and protect.

Kung wala pong CCTV footage, Ian's case would have been reduced to a statistic under the label of Legitimate Police Operations.

Ilan pa po ba ang kailangang mamatay bago natin harapin ang isang napakasakit na katotohanan — na ang ating pag-asa sa karahasan bilang pangunahing solusyon sa problema ng droga at iba pang problema ng ating bayan ay hindi magdudulot ng kabutihan sa ating bayan, bagkus magdudulot lamang ng mas marami pang mga bangkay at mas marami pang mga pamilyang wasak at nagdurusa.

There must be other ways. There have to be other solutions to our drug menace – solutions through education, through a stronger justice system, through rehabilitation, through an upstanding and outstanding police force, through proper and legal enforcement procedures, through anti-poverty efforts and programs that provide jobs and livelihood.

Solutions na in fairness, itinataguyod natin sa Senado sa mga batas, polisiya at programa na sinusulong ng bawat isa sa atin dito.

Ngayon po na magkakaisa ang Senado sa paghahanap ng katarungan para kay Ian, huwag din po nating kalimutan ang iba pang naging biktima ng collateral damage, mistaken identity at mga biktima ng mga extrajudicial killings.

We need to put an end to these killings. We need to hold persons in positions of power and authority accountable to the Filipino people.

Para po kay Kian, para po sa ating kabataan, para sa ating bayan.

REFERRAL OF SPEECH TO COMMITTEE

Upon motion of Senator Zubiri, there being no objection, the Chair referred the privilege speech of Senator Aquino to the Committee on Public Order and Dangerous Drugs.

MANIFESTATION OF SENATOR LACSON

Taking note of the privilege speech and a resolution – as had been agreed upon in a majority caucus—that would be read for referral to the Committee on Public Order and Dangerous Drugs, Senator Lacson informed the members that his committee has scheduled a hearing on the said resolution as well as on the other related speeches at 2:00 pm on Thursday, August 24, 2017.

PRIVILEGE SPEECH OF SENATOR HONTIVEROS

Availing herself of the privilege hour, Senator Hontiveros called for an end to the bloody killings resulting from the Duterte administration's war on illegal drugs.

The full text of Senator Hontiveros' privilege speech follows:

I rise on a point of personal and collective privilege.

Alam na po natin lahat ang kuwento ni Kian de los Santos. But maybe the facts bear repeating. On August 17, at night, a 17-year-old was killed as part of last week's bloody rampage, where more than 90 people in Bulacan, Caloocan and Manila have been felled by elements of the police force as part of the war on drugs. Kian de los Santos, a grade 11 student, would just have been part of the statistics had it not been for the CCTV footage showing that Kian was being bodily carried by two men, and eyewitness accounts saying that at no point did he try to shoot at those apprehending him. In fact, he was begging for his life: "Tama na, tama na, may exam ako bukas," being his last words. Sa madaling salita, malinaw ang ebidensya na hindi siya nanlaban. His lifeless body was shown in fetal position, and in a later autopsy conducted by the Public Attorney's Office, it was found that he sustained three fatal wounds, one of which was identified to be a treacherous wound.

My staff and I went to visit the wake of Kian and to pay our respects. It was there that the family discussed with me their security and practical concerns, and the legal steps that they planned to take. When my office took custody of the witnesses, it was in response to the request of these witnesses and their families, and even the family of Kian, to protect them from the threats that they have been receiving. Sa Senate hearing sa Huwebes, titiyakin ko ang pagdalo ng mga testigo at hihilingin ko rin sa aking mga kasama na sila ay protektahan nang maigi. The primary priority of my office is the protection of these witnesses and their testimony, and to do what we can from our end to secure justice for a 17-year-old boy felled by agents of the state.

Yesterday, President Duterte broke his silence on the Kian de los Santos issue by vowing that police officers behind the killing will be thrown in jail. In the same breath, he said that

he cannot put so many pressures on the police and he cannot condemn them without validation.

Naalala ko ang pamagat ng paborito kong pelikula ni Lino Brocka, "Tinimbang Ka Ngunit Kulang."

While we welcome the commitment of the President to allow the investigation of the policemen involved in the murder of Kian de los Santos, this does not, this cannot make us forget his other words that have inspired, abetted and condoned the senseless killings in the name of the war on drugs.

Paano pa niya sasabihin na bibigyan niya ng independyenteng imbestigasyon ang pagkamatay ni Kian, pagkatapos iutos ng pangulo ang reinstatement at hayaan ang promotion ni Police Supt. Marvin Marcos, na sinasabing nanguna sa extrajudicial killing ni Albuera Mayor Rolando Espinosa Sr.?

Paano natin siya paniniwalaan pagkatapos ikatuwa ng Pangulo ang malaking bilang ng mga taong napaslang sa one-time, big-time operation ng PNP, kung saan napaslang si Kian de los Santos, at sinabi pa ng Malacañang na "there is rhyme and reason in the police operations"?

Paano natin mahahanapan ng "good faith" ang kanyang pananalita, kung noong Disyembre 2016 lang, sinabi ng Presidente na "o pag walang baril, bigyan ng baril." Kung tama ang mga testigo, ganyan na ganyan ang ginawa kay Kian.

The President's hands are stained by the blood of Kian, and the blood of the 12,000 murdered in the name of his bloody war on drugs. He inspired this culture of impunity and killing. He reveled in the deaths of drug addicts, while at the same time turning a blind eye on the big drug lords close to him and his family.

And to all Filipinos who denied the existence of extrajudicial killings for whatever reason — maybe because of your support for this President, your disgust for drugs and crime, your belief that iron fists are necessary for "real change" — maybe some reflection is in order. Baka dapat natin pagnilayan kung ano ang naging papel natin at nahantong tayo sa ganito. They were shocked at the death of Kian because they could not ignore the CCTV footage. They had no choice but to confront his death because his narrative was compelling — mabait na bata, wala sa drug list, mag-e-exam sa susunod na araw. They felt stirred into action because they could no longer ignore

the growing outrage from a country you had thought had grown callous to death. But Kian was not the first. That there were thousands of deaths before him and that you allowed it to happen by denying EJKs is something you have to live with.

But Kian can be the last, or one of the last. Maari pa natin pigilan ang mga susunod na Kian. O ang mga susunod na Danica Garcia, Angel Fernandez, Rowena Tiamson. Para sa kanilang sinabing nanlaban, manlaban tayo. For them, we must keep on fighting.

MANIFESTATION OF SENATOR PACQUIAO

Senator Pacquiao gave the following manifestation to express his condemnation on the senseless killing of Kian delos Santos:

I would like to manifest that I am with you in condemning the abuses by the police resulting in excessive and unnecessary deaths in the conduct of the campaign against illegal drugs. I agree with you that there should be a Senate inquiry on the PNP's responsibility and accountability on the conduct of the anti-drugs campaign.

For the record, I fully support President Duterte's war on drugs but I do not support the senseless killings ng mga abusadong pulis.

Noong nakaraang Linnggo, maraming namatay dahil sa malawakang anti-drug raid operations.

Saludo po ako sa mga matitinong police enforcers nguni't galit naman tayo sa mga pulis na umaabuso sa kanilang kapangyarihan at pumapatay ng mga inosenteng mamamayan.

Just like you, I condemn the brutal killing of Kian delos Santos. Kian was only Grade 11. Kian was just 17 years old. That was a senseless killing of a minor.

Even President Duterte said that if police murdered Kian delos Santos, siya mismo ang maghahatid doon sa kulungan o magpapakulong sa kanila. At iyan po ang paninindigan ng ating Pangulo na nililinaw lamang niya na inii-instruction-an ang mga pulis na gawin ang kanilang trabaho pero hindi naman iniinstruction-nan ng Pangulo na labagin ang batas. Kaya ang sabi ng Pangulo na imbestigahan kung sino ang may pagkakamali o kung may pag-aabusong ginawa ang mga pulis, at siya mismo ang magpapakulong.

I fully support the war on drugs but not at the expense of the rule of law. It is our moral duty to uphold the principle of due process.

With this, I manifest my support to Proposed Senate Resolution No. 471.

COSPONSORSHIP SPEECH OF SENATOR BINAY

Senator Binay delivered her cosponsorship speech

on Senate Bill No. 1455, or The Filipino Sign Language Act, as follows:

The State recognizes the rights, privileges, and freedoms of persons with disabilities (PWDs) with the adoption of policies and programs that would develop their self-reliance and self-development, as well as promote their rehabilitation. This is in consonance with the United Nations Convention on the Rights of Persons with Disabilities that promotes and protects the rights of PWDs and their full enjoyment of it.

National and local state agencies shall uphold respect for their inherent dignity, individual autonomy, and independence by guaranteeing accessibility and eliminating all forms of discrimination in all public interactions and transactions, thereby ensuring their full and effective participation and inclusion in society.

Part of these policies is ensuring that our fellow Filipinos who are hard of hearing or deaf are able to exercise their right to expression and opinion without prejudice to their condition. It is estimated that around 120,000 Filipinos are deaf, according to the national census done in the year 2000. The figures might have gone up in the past 17 years and I fear that there are more and more PWDs who do not enjoy their rights.

There is a need to identify and adopt standards that would guide the development and advancement, especially in communicating, of the deaf and hard of hearing. The State should recognize and promote the use of sign languages embodying the specific cultural and linguistic identity of the Filipino deaf.

The Filipino Sign Language (FSL) shall be recognized, promoted, and supported as the medium of official communication in all transactions involving the deaf, and as the language of instruction of deaf education, without prejudice to the use of other forms of communication depending on individual choice or preference.

With the passage of this bill:

- FSL will be used in all government transactions, most especially in the judiciary, in the health system, and in frontline offices that provide services to the deaf. Closer to home, qualified FSL interpreters should be provided in our Senate hearings, sessions, and other activities.
- There will be a national system of standards, accreditations, and procedures for FSL interpreting, as well as policies on the practice of interpreting as a profession.

- FSL will be the medium of instruction in deaf education, as well as part of the curriculum for deaf learners. Training materials in the education of the deaf will also be developed and training for teachers will be undertaken.
- The KBP and the MTRCB, the deaf community, and other stakeholders will create a national system of standards, procedures and accreditation for broadcast media interpreting in FSL. All videos published online including those on social media, shall also conform to Philippine web accessibility standards.
- Appropriate steps to propagate sign language competency among hearing people will also be promoted.

In the end, the passage of this bill would free our fellow Filipinos who are deaf or hard of hearing from illiteracy, marginalization, and oppression; and make them partners in nation-building.

So I urge my colleagues, let us pass Senate Bill No. 1455.

COMMITTEE REPORT NO. 156 ON SENATE BILL NO. 1558

Upon motion of Senator Zubiri, there being no

objection, the Body considered on Second Reading, Senate Bill No. 1558 (Committee Report No. 156), entitled

AN ACT DEFINING AND PENALIZING GENDER-BASED STREET AND PUBLIC SPACES HARASSMENT, EXPANDING THE DEFINITION OF SEXUAL HARASSMENT, AND AMENDING FOR THIS PURPOSE REPUBLIC ACT NO. 7877, AND FOR OTHER PURPOSES.

Pursuant to Section 67, Rule XXIII of the Rules of the Senate, with the permission of the Body, upon motion of Senator Zubiri, only the title of the bill was read without prejudice to the insertion of its full text into the Record of the Senate.

The Chair recognized Senator Hontiveros for the sponsorship.

SPONSORSHIP SPEECH OF SENATOR HONTIVEROS

Senator Hontiveros, on behalf of the Committee on Women, Children, Family Relations and Gender Equality, submitted for plenary consideration Senate Bill No. 1558, entitled "An Act Defining and Penalizing Gender-Based Street and Public Spaces Harassment, Expanding the Definition of Sexual Harassment, and Amending for this Purpose Republic Act No. 7877, and For Other Purposes" under Committee Report No. 156.

The full text of Senator Hontiveros' sponsorship speech follows:

"Hi, sexy!" "Wow legs!" "Pahipo naman!" "Ang ganda mo, te, L ako sa iyo!" "Hoy, babae ka ba o bakla?"

Imagine walking down the streets and alleys of the city, and being subjected to catcalls of that sort and wolf-whistles from jeering bystanders. Imagine feeling reduced to the sum of your body parts. Imagine being judged for the way you dress. And then, imagine having to fear this every day of your life. Imagine never feeling safe in the public spaces of the city that you call your home.

What I just described are the realities that confront women and LGBT every day in streets and public spaces. Street harassment and public spaces harassment remain to be a persistent

problem of our time. An overwhelming 88% of women aged 18 to 24 years old experienced sexual harassment in the streets (according to SWS in 2016). While wolf-whistling and catcalling are the more common cases, other forms of sexual harassment include stalking, rubbing or touching, indecent gestures, exhibitionism and public masturbation. Majority of these incidents take place on the streets and small alleys, but they have also been reported to happen in public vehicles, public washrooms, schools, and workplaces.

Seeking to address this problem, the Committee on Women, Children, Family Relations and Gender Equality wishes to sponsor on the floor Committee Report No. 156, entitled "Safe Streets, Public Spaces and Workplaces Act." This committee report consolidates Senate Bill No. 1326, or An Act Penalizing Gender-Based Street and Public Spaces Harassment; Senate Bill No. 1250, or the Anti Sexual Harassment Act of 2016; and Senate Bill No. 1254 filed by Sen. Grace Poe, otherwise known as An Act To Eliminate All Forms Of Sexual Harassment In Work Places, Educational Institutions, And Public Places.

This substitute bill imposes penalties against unwanted comments, gestures, and actions forced on a person in a public place without his/her consent and is directed at them because of his/her actual or perceived sex, gender, gender expression, or sexual orientation and identity. Specific acts include but are not limited to unwanted cursing, wolf-whistling, cat-calling, leering, sexist, homophobic or transphobic slurs, persistent requests for someone's name, number or destination after clear refusal, persistent telling of sexual jokes, use of sexual names, comments and demands, following, flashing, public masturbation, groping, and stalking.

Secondly, it also includes specific provisions for harassment in schools, harassment in public utility vehicles, and harassment in privately-owned spaces that are open to the public such as restaurants and malls.

Moreover, it addresses an important gap in our existing Sexual Harassment Law by penalizing peer-to-peer sexual harassment. This has been a long-sought amendment by women's rights advocates in recognition of the inherent power relations between the male and female gender that can lead to oppressions and aggressions even between individuals of similar rank in the workplace.

Finally, the bills provide for awarenessraising programs and educational modules in order to propagate awareness of and vigilance against gender-based street and public spaces harassment.

Our women and brothers and sisters in the LGBT community have a right to be protected in public spaces. Men and women should have the same opportunities to thrive within their cities and communities, and to have an active public life. Men and women have the right to feel safe in our workplaces. This cannot be possible if we constantly feel under threat of what lurks behind the shadows. Many countries have already recognized the pernicious problem of street and public spaces harassment. In fact, in Nicaragua, its street harassment law has generated so much awareness and consciousness that Nicaraguan women have been known to cry out "La ley!" (translated as, the law) right on the street when confronted with an abuser.

We needed our version of this law yesterday. Let us make our streets and public spaces safer for women. Let us make our schools and workplaces free from gender-based harassment and sexual violence. Let us make public recreation areas truly recreational and uplifting.

COAUTHOR

Upon his request and with Senator Hontiveros concurring, Senator Villanueva was made coauthor of the bill.

Senator Villanueva recalled fighting for the enactment of a similar measure when he was still a member of the House of Representatives as he further noted that a number of LGUs have ordinances similar to Senate Bill No. 1558.
