AN ACT CONVERTING THE LAND TRANSPORTATION OFFICE (LTO)
EXTENSION OFFICE LOCATED IN LAPU-LAPU CITY,
PROVINCE OF CEBU, INTO A REGULAR LTO DISTRICT
OFFICE AND APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. The Land Transportation Office (LTO) Extension Office
2 located in Lapu-Lapu City, Province of Cebu, is hereby converted into a
3 regular LTO District Office.

4 SEC. 2. The Secretary of the Department of Transportation (DOTr)
5 shall immediately include in the Department's program the operationalization
6 of the LTO Extension Office in Lapu-Lapu City, the funding of which shall be
7 included in the annual General Appropriations Act.

8 SEC. 3. The Secretary of the DOTr shall issue the necessary rules and
9 regulations within ninety (90) days from the effectivity of this Act.

1 SEC. 4. This Act shall take effect fifteen (15) days after its publication
2 in the *Official Gazette* or in a newspaper of general circulation.
