AN ACT UPGRADING THE BATAAN PROVINCIAL HOSPITAL IN THE PROVINCE OF BATAAN INTO A LEVEL 3 TEACHING AND TRAINING HOSPITAL TO BE NOW KNOWN AS THE BATAAN GENERAL HOSPITAL AND MEDICAL CENTER AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. The Bataan Provincial Hospital in the Province of Bataan is hereby upgraded into a Level 3 hospital with capacity as a teaching and training facility, in accordance with the standards of the Department of Health, to be now known as the Bataan General Hospital and Medical Center.

The authorized bed capacity of the Bataan General Hospital and Medical Center is hereby increased from three hundred fifty (350) to five hundred (500) beds, to be implemented for a period of not more than two (2) years from the approval of this Act.

SEC. 2. The existing medical equipment and facilities, its operating funds and construction of the needed infrastructure of the Bataan General Hospital and Medical Center are hereby upgraded to conform with and be commensurate to the increase in bed capacity as provided in Section 1 hereof.

- SEC. 4. The Secretary of Health shall promulgate the necessary rules and regulations for the implementation of this Act within sixty (60) days from its effectivity.
- SEC. 5. Republic Act No. 8561, upgrading the Bataan Provincial Hospital, is hereby repealed. All other laws, decrees, orders, issuances, rules and regulations, and parts thereof which are inconsistent with the provisions of this Act are hereby repealed, amended or modified accordingly.
- SEC. 6. This Act shall take effect fifteen (15) days after its publication in the *Official Gazette* or in a newspaper of general circulation.
