AN ACT INCREASING THE BED CAPACITY OF THE ADELA
SERRA TY MEMORIAL MEDICAL CENTER IN TANDAG
CITY, PROVINCE OF SURIGAO DEL SUR, [FROM TWO
HUNDRED (200) TO FIVE HUNDRED (500) BEDS,]
UPGRADING ITS SERVICES AND FACILITIES,
AUTHORIZING THE INCREASE OF ITS MEDICAL
PERSONNEL AND APPROPRIATING FUNDS
THEREFOR

*Be it enacted by the Senate and House of Representatives of the
Philippines in Congress assembled:*

1 SECTION 1. The authorized bed capacity of the Adela Serra
2 Ty Memorial Medical Center (ASTMMC) in Tandag City, Province
3 of Surigao del Sur is hereby upgraded. [from two hundred (200) to
4 five hundred (500) beds] ITS BED CAPACITY SHALL BE
5 INCREASED INCREMENTALLY AS DETERMINED BY
6 THE DEPARTMENT OF HEALTH.

7 SEC. 2. The existing service facilities and other services of
8 the ASTMMC are hereby upgraded to conform with the bed capacity
9 increase as provided for in Section 1 hereof.

1 SEC. 3. The existing medical personnel of the ASTMMC shall
2 also be correspondingly increased. The Department of Health, in
3 coordination with the Department of Budget and Management and
4 the Civil Service Commission, shall determine the additional
5 plantilla positions to be created and filled up upon prior
6 consultation with and recommendation by the ASTMMC.

7 SEC. 4. The increase in bed capacity of the ASTMMC [from
8 two hundred (200) to five hundred (500) beds] shall be implemented
9 INCREMENTALLY for a period of [not more than] AT LEAST
10 five (5) years from the approval of this Act.

11 SEC. 5. The Secretary of Health shall immediately include in
12 the Department's program the implementation of this Act, the
13 funding of which shall be included in the annual General
14 Appropriations Act.

15 SEC. 6. All laws, decrees, orders, issuances, rules and
16 regulations or parts thereof inconsistent with the provisions of this
17 Act are hereby repealed or modified accordingly.

18 SEC. 7. This Act shall take effect fifteen (15) days after its
19 publication in the *Official Gazette* or in a newspaper of general
20 circulation.
