

AN ACT ESTABLISHING A NATIONAL HIGH SCHOOL IN
BARANGAY CATIGAN, TORIL DISTRICT, DAVAO CITY TO
BE KNOWN AS CATIGAN NATIONAL HIGH SCHOOL,
AND APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the
Philippines in Congress assembled:*

1 SECTION 1. There is hereby established, under the
2 supervision of the Department of Education, a national high
3 school in Barangay Catigan, Toril District, Davao City to be
4 known as Catigan National High School.

5 SEC. 2. The Secretary of Education shall immediately include
6 in the Department's program the operationalization of the Catigan
7 National High School, the funding of which shall be included in
8 the annual General Appropriations Act.

1 SEC. 3. The Secretary of Education shall formulate the rules
2 and regulations implementing the provisions of this Act within
3 one hundred twenty (120) days after its effectivity.

4 SEC. 4. This Act shall take effect fifteen (15) days after its
5 publication in the *Official Gazette* or in a newspaper of general
6 circulation.
