MR. PRESIDENT:

The Committees on Local Government; and Electoral Reforms and People's Participation, to which was referred House Bill No. 5367, introduced by Representative Luis "Jon-Jon" A. Ferrer IV, entitled:

"AN ACT REAPPORTIONING THE SIXTH AND SEVENTH LEGISLATIVE DISTRICTS OF THE PROVINCE OF CAVITE TO CREATE AN ADDITIONAL LEGISLATIVE DISTRICT TO BE KNOWN AS THE EIGHTH LEGISLATIVE DISTRICT OF THE PROVINCE OF CAVITE"

have considered the same and have the honor to report it back to the Senate with the recommendation that it be approved with the following amendments:

- 1. On Page 1, delete Section 1, and in lieu thereof, insert a new Section 1 to read as follows:

Section 1. Section 1 of Republic Act 9727 is hereby amended to read as follows:

"Section 1. Legislative Districts. – The Province of Cavite, which shall have [seven (7)] **EIGHT** legislative districts to commence on the next national **AND LOCAL** elections after the effectivity of this Act, is hereby reapportioned as follows:

FIRST LEGISLATIVE DISTRICT

(1) Cavite City

(2) Kawit

(3) Noveleta

(4) Rosario

SECOND LEGISLATIVE DISTRICT

(1) Bacoor

THIRD LEGISLATIVE DISTRICT

(1) Imus

FOURTH LEGISLATIVE DISTRICT

(1) Dasmariñas

FIFTH LEGISLATIVE DISTRICT

(1) Carmona

(2) General Mariano Alvarez (GMA)

(3) Silang

SIXTH LEGISLATIVE DISTRICT

(1) GENERAL TRIAS CITY

SEVENTH LEGISLATIVE DISTRICT

(1) TRECE MARTIRES CITY

(2) INDANG

(3) TANZA

(4) AMADEO

EIGHT LEGISLATIVE DISTRICT

(1) TAGAYTAY CITY

(2) ALFONSO

2. On page 2, delete Section 2.
3. Renumber the succeeding sections accordingly.

4. The title of House Bill No. 5367 shall be amended to now read as follows:

**“AN ACT AMENDING SECTION 1 OF REPUBLIC ACT 9767,
REAPPORTIONING THE PROVINCE OF CAVITE INTO EIGHT LEGISLATIVE
DISTRICTS”**





AN ACT REAPPORTIONING THE SIXTH AND SEVENTH
LEGISLATIVE DISTRICTS OF THE PROVINCE OF CAVITE TO
CREATE AN ADDITIONAL LEGISLATIVE DISTRICT TO BE
KNOWN AS THE EIGHTH LEGISLATIVE DISTRICT OF THE
PROVINCE OF CAVITE

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

- 1 SECTION 1. *Reapportionment of the Sixth and Seventh Legislative*
2 *Districts.* – The Sixth and Seventh Legislative Districts of the Province of
3 Cavite are hereby reapportioned to create the Eighth Legislative District as
4 follows:
5 (a) The Sixth Legislative District shall be composed of the City of
6 General Trias;
7 (b) The Seventh Legislative District shall be composed of the City of
8 Trece Martires, and the municipalities of Amadeo, Tanza and Indang; and
9 (c) The Eighth Legislative District shall be composed of the City of
10 Tagaytay, and the municipalities of Alfonso, General Emilio Aguinaldo,
11 Magallanes, Maragondon, Mendez, Naic and Ternate.

1 SEC. 2. *Commencement of Reapportioned Legislative Districts.* – The
2 reapportioned legislative districts under Section 1 hereof shall commence in
3 the next national and local elections after the effectivity of this Act.

4 SEC. 3. *Incumbent Representatives.* – The incumbent Representatives
5 of the Sixth and Seventh Legislative Districts of the Province of Cavite shall
6 continue to represent their respective legislative districts until the new
7 Representative shall have been elected and qualified.

8 SEC. 4. *Rules and Regulations.* – The Commission on Elections shall
9 issue the necessary rules and regulations within thirty (30) days upon the
10 approval of this Act.

11 SEC. 5. *Repealing Clause.* – Republic Act No. 9727 and all other
12 laws, rules and regulations which are inconsistent with this Act are hereby
13 repealed, amended or modified accordingly.

14 SEC. 6. *Effectivity.* – This Act shall take effect fifteen (15) days after
15 its publication in the *Official Gazette* or in a newspaper of general circulation.
