





AN ACT INTEGRATING THE DR. EMILIO B. ESPINOSA, SR. MEMORIAL STATE COLLEGE OF AGRICULTURE AND TECHNOLOGY CAMPUS LEARNING SITE IN THE MUNICIPALITY OF CAWAYAN, PROVINCE OF MASBATE, AS A REGULAR CAMPUS OF THE DR. EMILIO B. ESPINOSA, SR. MEMORIAL STATE COLLEGE OF AGRICULTURE AND TECHNOLOGY TO BE KNOWN AS THE DR. EMILIO B. ESPINOSA, SR. MEMORIAL STATE COLLEGE OF AGRICULTURE AND TECHNOLOGY - CAWAYAN CAMPUS, AND APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:*

1           SECTION 1. The Dr. Emilio B. Espinosa, Sr. Memorial State College  
2 of Agriculture and Technology Campus Learning Site in the Municipality of  
3 Cawayan, Province of Masbate, is hereby integrated as a regular campus of the  
4 Dr. Emilio B. Espinosa, Sr. Memorial State College of Agriculture and  
5 Technology, hereinafter referred to as the State College. It shall be known as  
6 the Dr. Emilio B. Espinosa, Sr. Memorial State College of Agriculture and  
7 Technology - Cawayan Campus.

8           SEC. 2. The parcel of land presently occupied by the Dr. Emilio B.  
9 Espinosa, Sr. Memorial State College of Agriculture and Technology Campus  
10 Learning Site is hereby declared as the property of the State College, and the  
11 title shall be transferred under its name: *Provided*, That should the campus



1 cease to exist or is abolished, or should aforementioned parcel of the land be  
2 declared by the Board as no longer needed by the State College, ownership  
3 over the same shall revert to the Municipality of Cawayan.

4 SEC. 3. The amount necessary to carry out the initial implementation of  
5 this Act shall be charged against the current year's funding of the Dr. Emilio B.  
6 Espinosa, Sr. Memorial State College of Agriculture and Technology Campus  
7 Learning Site provided by the Municipality of Cawayan, Province of Masbate.  
8 The Municipality of Cawayan shall continue to provide the same funding to the  
9 Dr. Emilio B. Espinosa, Sr. Memorial State College of Agriculture and  
10 Technology Campus Learning Site corresponding to the funding given before  
11 the same is integrated into the Dr. Emilio B. Espinosa, Sr. Memorial State  
12 College of Agriculture and Technology until such time that the full funding  
13 requirement of the Dr. Emilio B. Espinosa, Sr. Memorial State College of  
14 Agriculture and Technology – Cawayan Campus is included in the annual  
15 General Appropriations Act.

16 SEC. 4. This Act shall take effect fifteen (15) days after its publication  
17 in the *Official Gazette* or in a newspaper of general circulation.
