INTRODUCED BY SENATOR PACQUIAO

AN ACT ESTABLISHING THE SARANGANI SPORTS TRAINING CENTER IN THE MUNICIPALITY OF ALABEL, PROVINCE OF SARANGANI AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

- 1 SECTION 1. There shall be established in the
- 2 Municipality of Alabel, Province of Sarangani, a sports
- 3 training center to be known as the "Sarangani Sports
- 4 Training Center", which shall be constituted as the
- 5 primary sports development and training center for the
- 6 Province of Sarangani.
- 7 SEC. 2. The Provincial Government of Sarangani and
- 8 the Municipal Government of Alabel, in coordination with
- 9 the Philippine Sports Commission (PSC), shall take the

- 1 necessary steps to upgrade, improve, and modernize
- 2 existing facilities, equipment and personnel and integrate
- 3 them into the newly created sports training center.
- 4 The Provincial Government of Sarangani and the
- 5 Municipal Government of Alabel, in coordination with the
- 6 PSC, shall create the necessary training programs,
- 7 appropriate tournaments and competitions, as well as the
- 8 system by which the facilities shall be maintained and
- 9 managed in order to accomplish the objectives and
- 10 purposes of this Act.
- 11 SEC. 3. The construction, establishment and operation
- 12 of the Sarangani Sports Training Center shall be funded by
- 13 the Provincial Government of Sarangani and the Municipal
- 14 Government of Alabel, and such funds as may be granted
- 15 by the PSC and by the Office of the President. In addition,
- 16 grants and endowments may be obtained from local or
- 17 foreign sources intended for sports development.
- 18 SEC. 4. The Chairman of the PSC shall immediately
- 19 include in the Commission's program the necessary

- 1 funding requirements of the Sarangani Sports Training
- 2 Center.
- 3 SEC. 5. The PSC, in coordination with the Provincial
- 4 Government of Sarangani, the Municipal Government of
- 5 Alabel, and other concerned stockholders, shall promulgate
- 6 the necessary rules and regulations for the implementation
- 7 of this Act within ninety (90) days after its enactment into
- 8 law.
- 9 SEC. 6. This Act shall take effect fifteen (15) days
- 10 after its publication in two (2) national newspapers of
- 11 general circulation. The publication shall not be later than
- 12 seven (7) days after the approval hereof.
