AN ACT RENAMING THE MOLINO BOULEVARD TRAVERSING
BARANGAY TALABA 4 AND BARANGAY SAN NICOLAS 3 IN
THE CITY OF BACOR, PROVINCE OF CAVITE AS BACOR
BOULEVARD

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. The Molino Boulevard which traverses barangays
2 Talaba 4, Niog 3, Ligas 2, Ligas 3, Bayanan, Mambog 4, Molino 2, Molino 3,
3 San Nicolas 1 and San Nicolas 3 in the City of Bacor, Province of Cavite
4 is hereby renamed as Bacor Boulevard.

5 SEC. 2. The Department of Public Works and Highways shall place
6 appropriate markers along Bacor Boulevard and issue the necessary orders
7 and circulars to implement the provision of this Act.

8 SEC. 3. This Act shall take effect fifteen (15) days after its publication
9 in the *Official Gazette* or in at least two (2) newspapers of general circulation.
